At 7:00 p.m., Supervisor Kenneth Miller called to order the Organizational Meeting, scheduled for Tuesday, January 7, 2020, at the Palmyra Town Hall, 1180 Canandaigua Rd, Palmyra, New York.

SPECIAL GUESTS

<u>Town Historian, Betsy Lewis</u>: Newly appointed Town Historian Betsy Lewis discussed with the board her desire to create a Palmyra Historian Facebook page. Her plan is to use this to post information and graphics, and to open discussion about Palmyra's rich history. The historian will constantly monitor the page and remove any negative comments that may

occur. It was suggested that she check the current Town of Palmyra page to see if history could become part of it, or if history should indeed be a separate page.

Albert Klafass, Chief Exec. Director FLA: The newly appointed Director of Finger Lakes Ambulance visited to answer any questions with regards to the services provided to our town. He reported that though he is a 28 yr veteran of EMS, he is new to his current position and still assessing the operation. He did state that FLA had over 10,000 calls last year, with 876 in the Town of Palmyra. Of all those calls, only 72 had called for mutual aid. Supervisor Miller and Mr. Klafass plan to meet soon to discuss what has happened in the past, and what may be possible in the future.

<u>Mike Catalano, EMS Advisory Board:</u> Mr. Catalano stated that from Mr. Klafass' comments, he was glad to see that patient care will still come first, and added that he thought perhaps inviting Rick Perry, from the Village Board, to the meeting would be beneficial when discussing a home base for FLA at the Village Fire Hall.

This undertaking of the Tax Collector is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Tax Collector; and

This undertaking of the Town Justices is further conditioned that they will well and truly keep, pay over and account for all moneys and property coming into their hands as such Town Justices; and

This undertaking of the Court Clerk is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Court Clerk; and

The Town does and shall maintain insurance coverage, presently with National Grange Insurance Company, (Policy # F01415412Y), in the sum of \$2,000,000.00 each for the Supervisor and Book Keeper, and \$1,000,000.00 for the Town Clerk, to indemnify against losses through the failure of the officers, clerks and employees covered there under faithfully to perform their duties or to account properly for all moneys or property received by virtue of their positions or employment, and through fraudulent or dishonest acts committed by the officers, clerks and employees covered there under.
