Voted – That the board of Supervisors of this county are hereby authorized to cause to be raised by tax on this town the ensuing year two hundred dollars in addition to two hundred and fifty dollars the sum allowed by law to pay for constructing or repairing roads and bridges in said town

Voted – that the collector of this town be allowed three per cent for the collection of taxes the ensuing year.

Adopted – the following resolution presented by the supervisor and read to the meeting and ? = via Resolved by the board of supervisors of wayne county that the legislature of this state be requested to ? a law authorizing said board to sell the poorhouses and farm attached thereto belonging to said county and providing that each town in said county shall support its own poor = whenever the said board state thus be instructed by the several towns of the said county.

Voted – that this meeting stand adjourned untill the first Tuesday of April? – then to be held at the Public House (Butler Still house) now held by Butler Newton in the village of palmyra at 10 o clock am
