Assistant superintendent Davitt represented the Gillespie Company at the meeting. Attorney G. S. Tinklepaugh represented the Town Board, and the matter of granting the permit was discussed. The meeting adjourned until Friday, February 10, 1911, so as more information could be gotten regarding Town's right to grant permit, etc.

Whereas the T. A. Gillespie Company, a corporation engaged as engineers and contractors on the Barge Canal working on contract 77 in the Town of Palmyra, Wayne County, NY, have made written application for permission to lay a siding from the West Shore Railroad across the town road opposite J. H. Walton's residence in said town to connect with Lock 29 of the Barge Canal, said siding to cross highway at grade.

And whereas, the applicant agrees to maintain the road or highway in the same condition as at present, not to obstruct traffic at any time, and has agreed to indemnify said town from any damages or claims for damages that may be made by reason of such occupancy of said highway by said applicant.

Resolved that permission be, and same hereby is granted to the T. A. Gillespie Company, a corporation having a New York office at 50 Church Street, New York City, to construct, maintain, and operate a siding or switch across the town road opposite J. H. Walton';s residence in the Town of Palmyra for the general purpose of connecting the West Shore Railroad with Lock 29 of the proposed Barge Canal contract and for a period of not exceeding three years. Said switch to be used for the purpose of transporting materials and machinery to be used in said Barge Canal construction and for the purpose of said Barge Canal work only. The consent is given by said town and accepted by applicant upon the express condition, nevertheless, that the said T. A. Gillespie Company shall:

<u>First</u>: Lay siding upon the present grade of the highway and in such manner as to permit the safe, convenient, and easy passage of teams and vehicles.

<u>Second</u>: At all times during the terms of this consent maintain said siding or switch in such a manner that no damage shall be caused to or suffered by the users of said highway.

<u>Third</u>: Not permit traffic upon said highway to be obstructed at any time by reason of cars or engines standing upon such switch within the bounds of said highway.

<u>Fourth</u>: At the expiration of three years from this date, or upon such prior date as the consent may be terminated, remove all rails, ties, and other materials used in said siding from within the bound of said town highway and restore the said road to as good condition as before the laying of said siding or as the highway shall then be maintained.

<u>Fifth</u>: At any time prior to the expiration of three years from date of this contract work upon Contract 77 west of the easterly line of Palmyra village shall be completed, take up, and remove all materials used in constructing said siding and leave the said highway in all respects in as good condition as above specified.

<u>Sixth</u>: Upon the violation of any of the condtions herein stated and upon thirty days notice in writing from said Town of Palmyra of its election to terminate this consent, remove said siding and all materials used in its construction from within the bounds of said highway within thirty days after service of notice from said Town of Palmyra in writing of its election to terminate this consent, and restore said highway to the same general condtion as herein before specified.

<u>Seventh</u>: Before any entry shall be made upon said highway, file a surety company bond with the Town Clerk of the Town of Palmyra in the penalty of not less that \$10,000 (ten thousand dollars) conditioned generally that the said T. A. Gillespie Company will save the Town of Palmyra harmless from all costs or damages which may be incurred or suffered by said Town of Palmyra by reason of this permission so granted and any of the acts of the said company there under, and it is further

Resolved that the foregoing consent shall not become effective until after said bond shall have been approved by the Supervisor of the Town of Palmyra and all other permissions for the said construction of siding necessary to be procured from the State Highway Commission with representation shall have been procured by the T. A. Gillespie Company.
