On motion of Justice Foster and seconded that \$650.00 be voted on at the Town Meeting Mch. 7, to pay the bridge note and interest the balance to go into the Highway Fund. The report of Overseer of Poor Bowman was received with vouchers and after due examination

on motion was accepted Balance on hand of \$98.09.

The report of the G.A. R. Relief Fund was presented by Henry P. Knowles and on motion fth same was received and approved. Mr. Knowles in behalf of G. A. R. Relief Committee asked for an appropriation of \$150.00 to be voted on at the Town Meeting to be held Mch. 7, 1899 for the G.A.R. Relief Fund on motion was approved.

Motion of Justice Foster and carried \$250.00 was transferred from the dog fund into the General fund.

On motion of Justice Tuttle that an appropriation of \$500.00 be voted on at the Town Meeting Mch. 7 for the Poor fund. The motion was carried.

Motion made and seconded by Justice Tuttle that the salary of the Overseer of the Poor be \$250.00 per year instead of \$300.00 as heretofore . Carried

Supervisor Griffeth the reports of the General fund, Dog fund & School fund

On motion made and seconded S. E. Braman and Wm. M. Parsons were appointed Poll Clerks and Henry M. Wood, Clarence A. Marshall were appointed Ballot Clerk to act at the Town Meeting to be held March 7, 1899.

On motion made and seconded & carried that there be voted on at the Town Meeting \$650.00 to pay balance of bridge note & interest.

On motion made and seconded the Supervisor was instructed to pay Garry Burns the Town share of license certificate rebate as it was shown that Mr. Burns had gone out of business before the expiration of his license.

The Clerk was instructed to make a minute that Mr. A. Lungdon during the year had received Poor orders to the amount of \$10.00 and had turned the same over to the Supervisor to apply On his account.
