Superintendent5 of Highways H. O. Young was present, and with the members of the Board discussed the agreement for the expenditure of highway money together with 320A construction for 1926.

The four copies of the Determination and Agreement sent to the Board by the State Highway Department were signed and forwarded to the State Department for their approval. The Agreement follows:

Top course to have 2 1/4 gal. bit material per square yard with a roadway between ditches 26 feet.

Mr. Young also reported that there had been a bad washout on the short road leading west from the West shore Station to Maple Avenue, but he had improved this road, as it was again passable.

Supervisor reported one-half of the allotment of the school money for the five districts of Palmyra with the exception of the apportionment of District No. 4, which was ordered withheld until the proper extension of the teacher's certificate in that district had been granted.. The amount of the money consisting this first allotment was \$6215.24.

At the close of the meeting, the members of the Board looked over several of the roads with Town Superintendent Young. No further business appearing, the meeting adjourned.

The Board adjourned for a few minutes and made the necessary inspection and decided that the gravel from the Cleason Pit would be the best for this type of work and instructed the Town superintendent to enter into an agreement with the owners for the necessary amount to be used.

The Board re-convened in session and discussed various problems regarding the building of 320A Road, and Superintendent stated he would start this work just as soon as he had finished work on the town roads.

The Board discussed at length with Mr. Young, Town superintendent of Highways, who was present at the meeting, the advisability of procuring additional loading capacity in the gravel pit. Mr. Young reported that the loader purchased about six years ago was not in very good condition. He advised the renting of a steam shovel for a period of four or six weeks. A representative of Z. T. Darrow Company of Canandaigua was present, and he stated that his firm would lease a machine to the Town of Palmyra for \$750.00 per month, including operator. At the expiration of the time the machine was leased for, the Town wished to purchase the machine the total rental paid less the cost of the operator would be allowed towards the purchase price of the machine, which was \$5500.00.

After a thorough discussion of the subject, the Board adopted the following resolution: Resolved that the town of Palmyra enter into a contract agreement with the Z. T. Darrow company whereby the said company would lease a tractor gasoline shovel to the Town of Palmyra for the sum of \$750.00 per month including operator. At the expiration of the rental time, said Company would sell to the Town of Palmyra the shovel for \$5500.00 less the amount of the sum paid for the rental minus the cost of the operator.

The meeting was called for the purpose of the advisability of purchasing on the lease plan the the tractor gasoline shovel of the Z. T. Darrow company, which was now being hired of the said Darrow Company at a cost of \$750 per month. The matter was thoroughly discussed, after which the following resolution was unanimously adopted: Resolved that the town of Palmyra with the consent of the County Superintendent of Highways enter into a contract with the Z. T. Darrow Company of Canandaigua for the purchase under the lease plan of the Model #3 Gas Crawler Keystone Excavator now being rented of the said Darrow Company at a monthly rental of \$750 per month. The purchase price of said excavator is to be \$5500, less the amount of the total rental due to this date. And be it further resolved that the said machine be paid for under the rental plan at a daily rental of \$30 for every day that the machine is used.

Town Superintendent Young stated that he was drawing a large amount of gravel to the country roads in the eastern part of the Township and that the excavator had proven to be a great help and a saving of money in the work. Mr. Young stated that he had opened a new gravel pit on the goldsmith Farm south of East Palmyra and that he was saving long hauls by being able to secure the gravel for the eastern part of the Town from this pit.

Meeting was called to order by Supervisor Averill, who stated that the object of the meeting was to take up the matter of sending Margaret Berns, who is about 18 years of age and who is an inmate of the County Home, owing to her being incapacitated for work from the effects of paralysis.

Overseer of the Poor, A. C. Hopkins, and Miss Lyford, the Red Cross Secretary for Wayne county, were present at the meeting to explain a plan whereby the young woman could be sent to a school where she could be instructed in office work, thus in time relieving the cost of maintaining her at the County Home. The Red Cross Secretary stated that the state would pay her tuition in such a school at Geneva; and if the Town would pay her board while in school to the amount of \$10 per week. She also stated to the Board that in the judgment of the representatives of the school, who had observed the patient that it would take about one year for her to finish her course in school.

The matter was discussed at length, and then a resolution was passed authorizing Overseer of the Poor, A. C. Hopkins, to transfer the young woman from the Wayne county Home to the school in Geneva and to draw orders for her board while in the institution in the sum of ten dollars per week.

On motion of Mr. Chapman, seconded by Mr. Spier, the following resolution was adopted: Resolved that it being shown to the satisfaction of the Assessors of the Town of Palmyra and the members of the Town Board of said town that the assessment of the Bank Stock of the First National Bank of the Town of Palmyra was erroneously assessed for the year 1926. The said bank paid a tax in excess of what the assessors deemed was correct; therefore be it resolved that the Supervisor of the Town of Palmyra be instructed to ask the Board of Supervisors of Wayne County to deduct the amount of the tax caused by said erroneous assessment from the amount levied against the above named bank to be collected in 1927.
