AGENDA ITEM (for Town Board only)

1. Approve: Cost and Scope of LaBella Work Proposal (No. P2302387): Todd Pipitone made the motion to approve the cost and scope of LaBella Work Proposal (No. P2302387) for Wetland Delineation and Erosion and Sediment Control Plan for the Old Palmyra Landfill, Garnsey Road, Palmyra NY, with the lump sum cost not to exceed \$7,250.00 for Tasks 1 & 4. (NOTE: Task #2 – Wetland/Stream Delineation \$3,000.00 and Task #4 – Regulatory Permitting Services \$5,200.00, will only be completed if required, and only with additional authorization from the Town)

Second: Doug DeRue Vote: 4 Ayes. Carried

WORKSHOP: TOWN & VILLAGE BOARDS

Deputy Supervisor welcomed first Michael Cocquyt (LaBella Senior Program Manager) and Barbara Johnston (Senior Planner) from LaBella Associates, and later Matt Horn (Director of Municipal Services) from the MRB Group, to discuss our options and their writing services in preparing a new Town & Village Comprehensive Plan.

Both companies agreed that it was time to dig into a new plan since ours had not been updated since 2004, had similar information for the boards as far as deadlines for Comp Plan Grant availability, initial community brainstorming, recommendations for a diverse community or "stakeholders' group" to be part of the entire process, and how each company would support our community in this process as it moves along.

Much discussion ensued, with the major questions being cost to apply for a grant to write the comprehensive plan (both around \$5,000) and the actual cost of the Comprehensive Plan. This was the biggest difference. LaBella stated that it would be approximately \$65-\$70 k, and MRB was \$50 k. Both companies were very professional, very knowledgeable in this business, seemed very easy to work with, and the village and town have had working relationships with both companies. Both representatives congratulated the Town & Village for working with each other!

Because of the timing and uncertainty of the grant to write a comprehensive plan (not getting a grant to write it and then reapplying could add 3 yrs.!), the boards asked that the clerk follow up with LaBella and MRB to get references from communities like ours, and ask if the grant could be acquired to *pay back* the cost to the town and village if we moved forward with just preparing a plan first without a grant to write it.

The boards discussed meeting for another workshop on Tuesday May 9th, 2023.
