A portion of Section 1198 of the Education Law reads as follows: "A local historian shall be appointed as provided in this section for each city, town, or village." At a recent meeting of County Historians held in Albany, we were urged to see that all towns comply with this law and appoint a historian to work with and under the supervision of the County Historian. Also at that meeting, an association was formed which shall be known as the "NYS Association of County Historians" and shall include in its membership all local historians who are appointed pursuant to Section 1198 as above quoted, upon recommendation by their County Historian and upon favorable action by the Executive Council of the Association.

I trust you will appoint a historian for your town at the earliest possible time and notify me of the appointment, so that I may take necessary steps to have her (or him) certified at Albany and also meeting with me to plan the work to be undertaken. There is material of great historical interest and value in every town, and with the help of the Town Historians, we hope to get it in shape for filing in the Division of History and Archives of the County quickly. The State Archives and Supervisor of Records has promised to visit Wayne County in the near future, and we hope to have enough data and material collected so that he can set up the department according to specifications. I feel that each Town Board should provide an item in the budget for compensation and expenses of the Historians, which will be adequate enough to include their attendance at the proposed internship for local historians next summer at Albany to study with the heads of the State Museum, State Library, State Historian's Office, and the Secondary School Program. It will give them courage, incentive, and knowledge to do a better service for the community which they serve.
