Town of Palmyra Minutes - 1928

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Thursday, January 12, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Town Clerk. The meeting was called to order by the Supervisor, and minutes of the last meeting were read and approved.

The Bonds of Supervisor Averill, Justices Chapman, Spier, Ziegler, and Young, Town Clerk Williamson, and Town Superintendent DeBrine were examined and approved by the Board.

On motion duly made, seconded, and carried, the following Inspectors of Election were named to serve in the three Election Districts of the Town of Palmyra according to the provision of the

Election Law: District No. 1 C. A. Tuttle

District No. 2 Harry D. Braman

On motion of Mr. Chapman, seconded by Mr. Spier, a resolution was adopted authorizing Justice L. C. Ziegler and Town Superintendent DeBrine to attend the annual meeting of the County Superintendents of the State to be held at Albany on January 26, 27, and 28. Their expenses are to be a regular town charge.

The Clerk reported that all the officers elected at the November election had taken their oats of office prior to January 1st, 1928.

By reason of the Village of Palmyra making some changes in the Village Hall, a room on the east side of the building was available for the Town Clerk's Office. As the room would be much better in every way than the present space used in the Justice Court Room, a resolution was passed authorizing the Town Clerk to move into the new quarters as soon as the Village could finish the decorating of the room, now in progress. The Justice Court Room is now being used for court purposes as before.

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Tuesday, March 20, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley R. Young, Justices; and Harry E. Williamson, Town Clerk.

Meeting was called to order by Supervisor Averill, and the minutes of the last meeting were read and approved.

County Superintendent of Highways LaVan Barnes appeared before the Board with Town Superintendent DeBrine in regard to the Highway Determination and Agreement for 1928; and after a thorough discussion of the same, a resolution offered by Mr. Ziegler, seconded by Mr. Spier, was adopted, fixing the terms in the Agreement as follows. The Town Clerk was instructed to fill out the various copies and file with the State Highway Department.

Primary Work \$80.00 per mile for 80 miles Special Improvements

A. Commencing at the south corporation line of the Village of Palmyra and running thence south on the Johnson Road to the Manchester Town Line, a distance of of 1.10 miles. Gravel sub-base 12" thick rolled in place and 12 feet wide. Bituminous macadam top course 4" thick rolled in place 12 feet wide with 2 1'2 gallons bituminous materials per square yard. Width of roadway between ditches 26 feet. Funds available: State & County Aid \$5663.16; Motor Vehicle Fund \$3600.00; Town Share \$1000.00; Balance 1927 county Aid None. Reserve Fund \$6974.18

A resolution was duly adopted appointing James White, Bert Storms, and John Storr as Special Constables in accordance with the provision of the Town Law covering such appointments.

The matter of the purchase of a Ford truck to take the place of the old Ford truck, which had been in use several years was taken up. The Town Superintendent was authorized to place an order with U. W. Sherburne for a 1928 Ford truck under the lease plan.

No further business appearing, the meeting adjourned. Harry E. Williamson, Town Clerk

Regular meeting of the Town Board was held in the Town Clerk's Office on Wednesday, April 18, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley R. Young, Justices; and Harry E. Williamson, Town Clerk. Meeting was called to order by supervisor Averill, and minutes of the last meeting were read and approved.

The resignation of Carlton H. Hedden as Assessor was received from Mr. Hedden, who is spending the winter at Phoenix, Arizona, stating that his health would not permit him to assume the duties of the office for the coming year. On motion of Mr. Ziegler, seconded by Mr. Chapman, the resignation was accepted with deep regret. The Clerk was instructed to file the same.

As the time for the Assessors to begin their regular work necessitated an appointment of an assessor at once. A resolution made by Mr. Kingsley Young, seconded by Mr. Spier, was carried appointing Orie Tack to the Office of Assessor to fill the term of Mr. Carlton Hedden. The Clerk was instructed to notify Mr. Tack of his appointment.

The matter of the purchase of a gasoline roller, which has been under consideration for some time was brought up at this time and discussed at length; but it was decided to defer such purchase until another year.

On motion of Mr. Young, duly seconded and carried, the compensation of the Assessors was fixed at \$5.00 per day for the year 1928.

Meeting of the Palmyra Town board was held at the Town Clerk's Office on Saturday, Mary 12, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Town Clerk. Meeting was called to order by Supervisor Averill, and minutes of the last meeting were read and approved.

Town Superintendent DeBrine was present at the meeting, and the matter of the purchase of a two-ton truck under the lease plan was taken up and discussed at considerable length with the result that a committee was appointed, consisting of Justices Spier, Chapman, and Ziegler to look into the purchase of a suitable two-ton truck at once with power to purchase. Said committee to confer with Town Superintendent DeBrine and County Superintendent Barnes in regard to any purchase.

The matter of the purchase and installation of a suitable gasoline tank for Town's use and located at the Town House was taken up and discussed. It was shown that a great saving to the Town would result in the Town being able to buy gasoline by the wholesale in the open market through owning their own storage tank and equipment; and after much consideration, a resolution was passed naming a committee consisting of Justices W. H. Chapman and W. E. Spier, together with Town Superintendent to purchase such equipment at a cost not to excess \$150.00.

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Monday, May 28, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Town Clerk. The meeting was called to order by Supervisor Averill, and minutes of the last meeting were read and approved.

The committee appointed at the last meeting to purchase a two-ton truck reported that they had entered into a contract with Frank P. Hunt of Rochester for the purchase of a two-ton truck with hoist and dump body under the lease plan at a sum of \$20.00 a day rental until the purchase price of \$3235.00 had been completed. The lease has been approved by the County Superintendent of Highways, the members of the Town Board, and the Town Superintendent had also executed the lease. The truck had been delivered and was now at work on the roads.

The Town Superintendent also reported that the Ford truck for which purchase had been authorized at a meeting on March 20 had been delivered. The lease had been approved by the County Superintendent and signed by the members of the Board. The lease calls for a payment of \$10.00 a day until the purchase price of \$775.00 is paid.

On motion of Mr. Ziegler, seconded by Mr. Spier, a resolution was adopted authorizing Health Officer Dr. R. A. Reeves to attend the State Health Conference at Saratoga and that his necessary expenses be a town charge.

Meeting of Palmyra Town Board was held at the Town Clerk's Office on Tuesday, June 26, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Town Clerk. The meeting was called to order by Supervisor Averill, and minutes of the last meeting were read and approved.

The matter of installing electric lights in the polling place in Election District No. 3 was discussed. On motion duly carried, the Town Clerk and Justice Kingsley R. Young were appointed a committee to investigate the matter with the Electric Light Company and electrician with power to act.

The committee appointed at the meeting of May 12, 1928, composed of Justices Spier and Chapman to act with the Town Superintendent in looking up the purchase of a gas tank and pump for the use of gasoline supply at the Town House reported that the tank, pump, and equipment had been purchased at a cost of \$107.00. The same had been installed and was now in use.

A resolution was adopted authorizing and instructing the Supervisor to pay for the same out of the General Town Funds.

Supervisor Averill reported County Superintendent Barnes and Town Superintendent DeBrine, who were present at the meeting, that the sum of \$6433.97 had already been expended in Item One of the General Highway for General Repairs and that the State Aid Money amounting to \$3037.82 had been received on June 26, 1928, and had been placed to the credit of the General Highway Fund in the State Bank. The Bank reported a balance of June 26th of \$9620.14. The other highway balances as given by the bank on June 26th were: Machinery Fund \$566.59; Snow and Miscellaneous \$4856.65. The Supervisor reported that there had been no orders drawn on the Bridge fund so far this year and that the bank balance in that fund was \$6637.87. The Supervisor also reported that in the General Town Fund there was a balance of \$16,694.62 as reported by the First National Bank on June 2, 1928.

Town Superintendent DeBrine reported that he would be able to complete the primary road work about July 1st and that he would be able to begin the 320A work about July 10th. The 320A project for 1928 begins at the Village and Town Line on Johnson Street and extends a distance of 1.10 miles south to the Town Line.

Mr. DeBrine stated that he though a gravel bed on the clemons Farm situated on the above highway would be available for the gravel to be used. The Board adjourned and with Mr. Barnes and Mr. DeBrine, they inspected the gravel bed and the highway to be improved.

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Tuesday, July 24, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Town Clerk. The meeting was called to order by Supervisor Averill, and minutes of the last meeting were read and approved.

A resolution was passed appointing Kingsley F. Young Attendance Officer for the School Districts outside of District No. 1 for the coming year at the same salary as last year, subject to the approval of the Education Department.

Supervisor submitted bank balances of July 24, 1928, as follows:

Supervisor reported that checks to the amount of \$7845.41 had been spent in General Repairs and that Mr. DeBrine thought he would be able to finish the primary work about August 1st.

The matter of the purchase of a new grader was taken up, and the Adams and Gallion Graders were taken in consideration. The specification and equipment with prices were discussed; and on motion the Board adjourned until Wednesday morning at 10 o'clock to inspect and witness a demonstration of the two machines.

The Board re-convened at 10 a.m., Wednesday with all members present.

The subject of the purchase of a grader was again taken up; and on motion of Mr. Ziegler, seconded by Mr. Chapman, the following resolution was adopted:

Resolved that the Palmyra Town Board in session on July 24-25, 1928, hereby enters into a contract with the Gallion Iron Works and Mfg. Company of Gallion, Ohio, for the purchase of Model E-Z88 Leaning Wheel Grader at the purchase price of \$1050.00 for immediate delivery. Be it further resolved that payment for said grader be made on or about February 15th, 1929, in the sum of \$1050.00 with no interest charge.

No further business appearing, the meeting adjourned. (signed) H. E. Williamson, Clerk

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Wednesday, August 29, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Town Clerk. The meeting was called to order by Supervisor Averill, and minutes of the last meeting were read and approved.

The matter of designating Polling Places was brought up. On motion of Mr. Ziegler, seconded by Mr. Spier, a resolution was adopted designating the following location for Polling Places for the coming year:

District No. 1 Justice Room, Village Hall Building
District No. 2 Garlock Garage, East Side, Fayette Street
District No. 3 Ziegler Building, East Palmyra

The Clerk reported that he had received a letter from the Attendance Division of the State Education Department at Albany stating that the appointment of Kingsley F. Young as Truant Officer made at a meeting of July 24th had been approved by the department

The question of purchasing new voting booths for the town was brought up. A communication was read from Pennsylvania Construction Company of Marietta, PA, stating that they could furnish a folding canvas voting booth 3x3x6-3 covering all the qualifications of the Election Law for \$7.35 each, with an additional charge of \$1.25 for each shipping crate f.o.b., factory. It was found that these booths were used extensively in NYS. On motion of Mr. Chapman, seconded by Mr. Young, a resolution was adopted authorizing the Town Clerk to order six of these booths for immediate delivery.

Town Superintendent of Highways DeBrine was present and stated that he had been instructed by the County Superintendent of Highways to repair the bridge on North Creek Road just east of the stone school house.

He had made such repairs as recommended by the County Superintendent and that the bridge was now open and estimated the expense would be about three hundred dollars.

Mr. DeBrine also reported that he was progressing rapidly with the construction of the 320A Project. He stated that the gravel bed open on the Clemons property was not going to be sufficient for the base of the road. He asked permission to move the steam shovel to the Rochester and Syracuse Pit, which was granted.

The Supervisor reported about \$9000.00 had already been spent in General Repair Work, and \$2919.57 had been paid out by check in the Machinery Fund. Mr. DeBrine reported that brush and week work had been suspended until fall. The Supervisor stated \$1204.68 had already been spent in this work

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Tuesday, September 25, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Town clerk. The meeting was called to order by Supervisor Averill, and the minutes of the last meeting were read and approved.

Town Superintendent DeBrine was present at the meeting and reported to the Board that he would finish up the base and grading on the 320A Project about October 15th and that he road would be ready for traffic at that time. After the base had been allowed to settle during the winter, it would then be ready for the top and the surface treatment early in 1929. Mr. DeBrine stated that it was his intention to the gravel roads a thorough inspection as soon as the work on the 320A Project was completed and put them all in as good a condition as possible before the fall rains set in.

The matter of purchasing either a blade or a V-shaped snow plow to be attached to the new GMC truck for the work of clearing the snow from the trunk highways through Palmyra, thus leaving the Linn Tractor and plow for the country highway snow removal was discussed at length. On motion, duly carried, the Supervisor and the Town Superintendent were instructed to make an investigation of the plows and report at the next meeting.

The matter of the purchase of a Safe Guard Check Writer and Bond to take the place of the check writer that had been in use in the Town Clerk's Office for a number of years was discussed. The Safe Guard Company agreed to install one of the machines for the sum of \$75.00 with an allowance of \$10.00 for the old machine. Said purchase to carry with it a bond for \$10,000.00 against forgery or check alteration. On motion, duly carried, Mr. Ziegler and Mr. Averill were appointed a committee to further investigate the subject with power to act.

Mr. Averill reported to the Board the expenditures in the General Highway since January firsts as

Regular meeting of the Palmyra Town Board was held at the Town Clerk's Office on Tuesday, October 30, 1928. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Town Clerk. The meeting was called to order by Supervisor Averill, and the minutes of the last meeting were read and approved.

Town Superintendent DeBrine was present and informed that he had closed work on the 320A Project for the year. The work of grading had been finished, and the base was completed. The entire length of the project and all sluices, culverts, and shoulders are complete. Permission had been given by County Superintendent Barnes to put the road in good condition for the fall and winter and then put the top on early in 1929.

The matter of purchasing a blade snow plow to be attached to the new GMC truck for use on the improved highways, leaving the Linn Tractor and plow for the country roads was discussed. It was decided to give the plow a trial. The Town Superintendent and the Supervisor were named as a committee with power to act and investigate the merits of the various blade plows.

The Town Superintendent reported that he had already graveled 15 miles of roads during 1928, and it was his intention to continue with this work as long as he could during the remainder of the year.

The Superintendent reported that he was unable to pay future bills in the Machinery Fund, as the \$3000.00 raised by tax in that fund had been paid out. After discussion, the following resolution was offered by Mr. Ziegler and adopted:

Owing to the fact that the sum of \$3000.00 raised by tax in the Machinery Fund for 1928, has not been sufficient to meet the necessary demands on this fund be it resolved that the Supervisor is hereby authorized and instructed to transfer at once the sum of \$500.00 from the General Town Fund to the Machinery Fund.

The matter of the Town Superintendent's highway estimate for 1929 was taken up and discussed at length. After due consideration, the estimate was adopted as follows:

Town Superintendent DeBrine stated that he was now engaged in getting the Town roads in the best possible condition for the winter, gravelling where it was necessary, and finishing up the cutting of weeds and brush. It was his plan to finish all this work by December 15th.

On motion of Mr. Ziegler, seconded by Mr. Chapman, a resolution was passed fixing the salary of the Town Superintendent of Highways at six and one-half dollar per day for 1929.

On motion of Mr. Chapman, seconded by Mr. Spier, a resolution was passed fixing the allowance of the Supervisor under the Highway Law at \$500.00 and the Town Clerk at \$200.00 a year for 1929.

On motion of Mr. Ziegler, seconded by Mr. Young, a resolution was adopted fixing the appropriating of the Town Clerk under the Election Law at \$200.00 per year for 1929.

After a general discussion of the road work, the Board took a tour of inspection of the town roads in company with Town Superintendent, adjourning until Friday morning at ten o'clock.
