Supervisor David Lyon welcomed those in attendance to the Public Hearing for the proposed Johnson-Floodman Water District. He asked if anyone wished to make comments concerning the water district. Robert Colletta commented first on Article 12, concerning the vote of real tax property owners, and asked if the \$680 annual cost was "written in stone." Dave Lyon said no.

Engineer Dave Doyle, representing MRB Group, which the town has hired to do the engineering for this water project, said the \$680 is the

"best guesstimate" of the cost. "The district, as it gets formed, will be formed on that basis." The town's costs cannot go over the approved amount. If the bids come in too high, the town has to come back to the residents for another hearing.

Colletta was also concerned about his assessment going up. Dave Lyon answered that houses with municipal water generally sell for a higher amount than those with wells and can, over time, affect the assessment.

PUBLIC COMMENTS AT HEARING

Jerry Misik asked if more people build in an area and are included in the water district would the cost per household go down? Dave Lyon said yes. Misik also asked what the price of hooking up would be. Dave Doyle said the standard fee is \$1400 for a hookup, which just about covers the actual cost of the services.

Bob Colletta raised his hand again to ask if current zoning laws prevent "sprawl building." Code Enforcement Officer Bob Grier said in the town there's a minimum lot size so there cannot be too dense of a development.

Colletta also asked if the meter needs to be in the house. Dave Doyle suggested he talk with the Water Authority. Dave Lyon added that for privacy's sake, all new meters are "radio read" so meter readers don't have to enter homes.

Cheryl Smyers asked if grant money is still available for the water project, and if residents have to pay for any other costs. Dave Doyle said the estimated cost includes receipt of grant funds. The amount listed on the information sheet would be the highest amount a homeowner should expect to pay. The law requires that the town cannot exceed the total amount of the project without coming back to the people.

HEARING CLOSED

Dave Lyon asked if anyone else wished to make comments concerning the proposed Johnson-Floodman Water District. Hearing none, he declared the hearing closed at 7:42 p.m.

- Truck plow frame/plow/wing/sander maintenance and setups all trucks
- Plowing/Sanding We have been out of the barn on five occasions this season
- Pothole patching various roads
- Mutual Aid
 - We assisted the Village of Palmyra on 11/13-11/14 for their sanitary sewer manhole cover replacement and asphalt patching efforts on Canandaigua Street.
 - We also assisted the Village of Palmyra on the Stafford Street sidewalk project throughout the entire project throughout October until its completion on 11/2
- Mowing update 10/25 was the last day for our mower man, Chris Bratt.
 We continued to mow back various roadsides for the next couple weeks as time permitted. We have also continued to brushmow with the Drott on several roads noted above.

HIGHWAY DEPARTMENT REPORT FOR NOVEMBER

- Roadside garbage/debris We picked up 30+ tires that were dumped in a
 creek along the roadside near the S. Townline intersection. I called the
 Sheriff's office to report the dumping and a report was taken. The neighbor
 saw/heard the vehicle and we are on the lookout. Additionally, while
 mowing along Jagger Road, a substantial amount of junk/debris has been
 observed which we will likely be picking up at a later date.
- Joint Fuel Facility On 10/25, NYS DEC officials visited and inspected our entire joint fuel facility. Pal-Mac CSD officials were also on hand. We received a positive grade and were advised that we would not be inspected again for the next seven years.
- Shop Hoist Update We are re-scheduling a trip to Victor Highway to review their lift system.

HIGHWAY DEPARTMENT REPORT FOR NOVEMBER

- Phone System For the past month Karen and I have been inquiring into a new phone system for the highway department. We have some quotes from vendors but are waiting to hear from Broadview Networks who provides the Town Hall and Highway Department phone service. We are in need of new equipment hardware. Our current system is over 20 years old. I plan to have all the quotes for review/discussion for the next TB meeting.

4. Resolution of Authorization for Town-wide Dog Enumeration: In 2008, a dog enumeration is proposed for all town residents. Dave Lyon noted one "hasn't been done in years." It would include notifying residents of the upcoming enumeration, publishing and posting a legal notice to this effect, and having someone go from house to house counting dogs, making sure

each has been licensed and vaccinated against rabies.

WHEREAS, Article 7, Section 114 of the Agriculture and Markets Law provides the governing body of any municipality may require its Animal Control Officer or any other authorized agent to ascertain and list the names of all persons in the municipality owning or harboring dogs, or in lieu thereof any municipality may contract to have the same done; and

WHEREAS, Article 7, Section 110 Sub 4 (d), license fees, of the Agriculture and Markets Law states in part: any person applying for a dog or purebred license for a dog identified as unlicensed during an enumeration conducted pursuant to subdivision 7 of section 114 of this article shall pay a fee of five dollars (\$5.00) in addition to the license fee; and

WHEREAS, for health and safety reasons it is important to the Town of Palmyra to know where dogs are being held in the Town; and

WHEREAS, the Town of Palmyra has not conducted a dog enumeration for many years;

NOW BE IT RESOLVED, that the Town Council and the Town of Palmyra authorizes the Town Clerk to plan and conduct a Dog Census for the Town of Palmyra, beginning in the month of February 2008, and anticipating ending in December 2008, between the hours of 8AM and 8PM with the cost of the Dog Census not to exceed the budgeted amount of \$2500.00. An additional charge of \$5.00 to be applied to those dogs identified as unlicensed as per Article 7, Section 110 Sub (d).

Participation includes a 10% match of funds, so the \$20,000 requested per municipality would be \$18,000 with \$2,000 local match.
