At 7:00 p.m., Supervisor Gary Rose called to order the public hearing and regular Town Board meeting, scheduled for Thursday, May 22nd, 2025, at the Palmyra Town Hall, 1180 Canandaigua Rd, Palmyra, New York.

HEARING

The following is the legal notice that had been printed in the Town's official newspaper, *The Times of Wayne County*, and posted on the Town Hall's bulletin board before the hearing, in accordance with law.

<u>OF PROPOSED LOCAL LAW</u>

PLEASE TAKE NOTICE that there will be a public hearing of the Palmyra Town Board in the County of Wayne and State of New York on May 22nd, 2025 at 7:00 PM at 1180 Canandaigua Rd, Palmyra, New York, to discuss the proposed Local Law #1-2025 "Real Property Tax Levy Limit".

1. That the said Local Law is to read as follows:

LOCAL LAW #1 - 2025 "Real Property Tax Levy Limit"

Section 1. Legislative Intent

It is the intent of this Local Law to override the limit on the amount of real property taxes that may be levied by the Town of Palmyra pursuant to General Municipal Law §3-c, and to allow the Town of Palmyra to adopt a budget for the fiscal year 2026 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

Section 2. Authority

This Local Law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by the vote of sixty percent (60%) of the town board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Palmyra, County of Wayne, is hereby authorized to adopt a budget for the fiscal year 2026 that requires a real property levy in excess of the amount otherwise proscribed in General Municipal Law, §3-c.

Section 4. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date.

This Local Law shall take effect immediately upon filing with the Secretary of State.

- **1.** Supervisor's Monthly Financial Report: The Supervisor has received the Bookkeepers monthly financial report for April 2025, which he also shared with the board.
- **2.** LaBella: Met with LaBella, things are moving along, and LaBella was authorized to send out bid packets early in May 2025, to be returned by mid-June, 2025. There was a meeting between our engineers and construction companies to answer any questions before they submitted any bids. The bids were to be opened on the 5th of June, and a few contractors went to look at the property. Now we anxiously wait to hear the figures.
- **3.** Changes in Employee Medical insurance: It is now time for open enrollment for employee health coverage. With the costs of healthcare rising about 15%, Petra and Gary met with our healthcare broker to

research options that would not only give comparable coverage but may even lower rates and save the town money. Information was provided to the employees for review, and we will be discussing different options including HRA accounts with our eligible employees on June 4th. Any questions at this time should be directed at Petra or Gary.

4. Scotts Clean Cut Property Maintenance: "Scotts" is willing to continue the contract as they took over the route of the previous company. We have changed the terms. The Church St Cemetery Hill will now be mowed every other week at \$125 per cut.

1. Highway Department Report for May:

Since the 4/24/25 Town Board meeting we have completed the following work:

- Treework Vault Road, Port Gibson Road, Hazen Lane
- Ditching/Culvert Work Jagger Road, Old Rt. 31, Omeal Road
- Dozer/Slope Work Cornwall Road, Jagger Road
- Brush Mowing Vault Road
- Hauling for various projects
- Equipment maintenance C1, C3, E64 sweeper tractor, E52 mowing tractor, T24 hoist cylinder

Other miscellaneous items include:

- Mowing Chris Bratt started back with us on 5/6/25. He has currently
 mowed all the northern half of Town and hopes to finish the south side
 next week, thus completing one round of mowing on our Town Roads.
 Then he will start mowing County Roads before starting back around the
 Town.
- CHIPs/PAVE/EWR/POP Funding The NYS 25-26 Budget has finally passed and we are receiving a \$50M increase to our CHIPs portion! Last year we received \$172,304.29. This year we are getting \$189,532.88, an increase of \$17,228.59 We will be receiving similar annual funding amounts for our PAVE, EWR and POP transportation program funding.

• Inspections:

- Fire Extinguishers all Hwy Dept fire extinguishers inspected by P.A.T.I on 5/14/25
- Vehicle Inspections all Hwy Dept vehicles have received annual inspections thru April 2025.

- Chainfall Inspection our annual chainfall inspection was completed by Han-Tek on 5/6/25.
- Lifting Chains all our lifting chains were inspected by Cook Iron on 4/22/25.
- Oil/Water Separator annual pump-out is in the process of being scheduled.
- Jeffery Road Drainage Issues It's been a wet Spring and from 5/6-5/7 we received 1.62 in of rain and had to patrol the Town to ensure our culverts were clear. Several culvert pipes at either end of Jeffery Road were problematic. WC Soil & Water met with us on 5/14 to review drainage issues here.
- Vault Road Project All this month we have been getting Vault Road ready for a recycle project. This past Tuesday, on 5/20, Suit Kote ground-up and re-paved the road. Sometime in June we intend to finish this job with a stone/oil surface.
- Parts Room Roof On 5/16/25 it briefly rained hard, and we experienced a leak in our parts room. Upon investigation we needed to reseal the flashing between the parts room metal roof and the main shop rear wall.
- Waste Tires to Nucor Steel during the first full week of May we commenced to cleaning up our lower lot brush pile, spoil dirt pile, scape metal, C&D pile and pile of old tires. Through the assistance of Wayne County Soil & Water, we loaded up 2 10-wheeler loads of old tires found along our roadsides and took to Nucor Steel in Auburn. A total of 240 tires were taken!

Any questions, comments or concerns I will be glad to answer.

Councilman Pipitone asked what was happening to the Maple Ave shoulders. Mr. Boesel said they were getting ready to surface treat and clean the culverts to make sure the water gets off the road. Councilman Welch explained to the students in the audience how littering takes up valuable and expensive time from our highway department.

TOWN CLERK OFFICE REPORT APRIL & MAY 2025

With the new law in effect requiring an enhanced license to travel even domestically (if you do not have a passport), our office has been very busy issuing certified copies of marriages which are required to prove identity to obtain one.... yes, even if you already have a driver's license!

Through dog licensing in March 2025, we sold 142 licenses totaling \$1,144.00, misc sales, marriage licenses, hunting/fishing, vital record requests, EZ-Pass, zoning, escrow deposits etc- added an additional \$3,075.26. Total check disbursements for the month of March were \$4,219.26.

Through dog licensing in April 2025, we sold 69 licenses totaling \$570.00, misc sales, marriage licenses, hunting/fishing, vital record requests, EZ-Pass, zoning, escrow deposits, etc- added an additional \$6,717.39. Total check disbursements for the month of April were \$7,287.39. As always at this time of year, we have had an upswing in marriage licenses issued!

Thank you to the WC Health Department, we now have the Tick Removal Kits once again. Supplies are limited, so we do ask to limit them to one per family.

I attended the 43rd Annual NYS Town Clerk Association Conference in April, in Albany, NY. I was able to participate in numerous classes, which is very helpful as there are so many changes in NYS law and how these topics are handled. There were major changes from the February AOT meeting that I attended to the NYSTCA meeting in April! I was very happy that Amanda received a partial scholarship and was able to attend the "New Clerk Track".

We will be hosting the Wayne County Town Clerks Association meeting here on June 11th, at noon. As Vice President of the Wayne County Association, one of my duties includes inviting various speakers to join us each meeting. This June, Mindy Robinson from the WC Board of Elections will be our guest speaker, and will discuss the rules, regulations, many changes in schedules, and requirements for elections.

I am working with the webmaster to obtain a .gov website for the town as that new state law will take effect in December. We already have the required information on our website, and after speaking to the IT Director at Wayne County, it seems we are in much better shape than most towns and villages! Having a .gov will make the process a little more expensive as we must buy that .gov URL, but Mr. Ury feels we should be able to redirect from .gov to our existing site. He is going to check with the .gov host that the county uses to see if there is a deal to be made if many towns utilize the company they use. More to come as we find out. I really hope that works or all cards, letter head, brochures, etc will need to be changed!

RESOLUTION #15-2025 RESOLUTION FOR HARRIET TUBMAN UNDERGROUND RAILROAD NEW YORK SCENIC BYWAY NOMINATION AND CORRIDOR MANAGEMENT PLAN ADOPTION

WHEREAS, the historic qualities of the Harriet Tubman Underground Railroad New York Scenic Byway, as described in the corridor management plan, and the surrounding areas have been appreciated and celebrated for over a century by the residents of New York State, as well as tourists, historians, artists, authors, and other visitors to the region; and it is this unique combination of the journeys of Harriet Tubman and those Freedom Seekers who traveled on the Underground Railroad that create the special sense of place that is vital in telling the New York story of the human desire for freedom and the historic sites they utilized during their journey to emancipation; and

WHEREAS, the Steering Committee of the Harriet Tubman Underground Railroad New York Scenic Byway, composed of representatives of 22 municipalities along the proposed scenic byway route, committed to working cooperatively to protect and promote the historic, scenic, recreational, and economic well-being of the 544-mile Corridor throughout the state and agreed to pursue the nomination of the Harriet Tubman Underground Railroad New York Scenic Byway; and

WHEREAS, under the leadership of the Harriet Tubman Underground Railroad New York Scenic Byway Steering Committee, each of the 22 counties contributed to the development of this corridor management plan by encouraging public participation, confirming the vision and goals, and leading individual meetings of the Collaborative; and

WHEREAS, the Steering Committee of the Harriet Tubman Underground Railroad New York Scenic Byway, consisting of relatives of Harriet Tubman, descendants of Freedom Seekers, Harriet Tubman and/or Underground Railroad historians, representatives from state and federal agencies, has strengthened the historic integrity, representation, and the principles of the corridor management plan; and

WHEREAS, in the process of developing this corridor management plan, the Harriet Tubman Underground Railroad New York Scenic Byway Steering Committee has strengthened the bonds of inter-municipal cooperation, and the involved entities envision further benefit through scenic byway designation including sustained collaborative progress, increased funding opportunities for recommendations identified in the plan, enhanced partnerships with agencies responsible for the stewardship of resources along and adjacent to the byway

route, and an improved visitor experience that interprets and promotes the corridor's intrinsic qualities and resources; and

NOW, THEREFORE, BE IT RESOLVED, that the Town of Palmyra supports the designation of the Harriet Tubman Underground Railroad New York Scenic Byway which includes programs for stewardship and enhancement of the historic scenic byway and guidance to manage future activities along its corridor; and

BE IT FURTHER RESOLVED, that the Town of Palmyra confirms that they will abide by and follow all existing New York State and Federal laws and regulations that are applicable to this resolution; and

BE IT FURTHER RESOLVED, that the Town of Palmyra will work in partnership, with the other municipalities along the Harriet Tubman Underground Railroad New York Scenic Byway and local and regional stakeholders in order to support future Byway programs, economic development, marketing, and collaborate with these interested entities to explore opportunities for cooperation to realize the Scenic Byway goals.
