In the matter of the establish of the East Palmyra Fire Protection District in the Town of Palmyra, County of Wayne, and State of NY, whereas there was duly presented to this Town Board a written petition in due form for the establishment of a fire protection district to embrace the territory situated in this town and hereinafter described. It duly appearing that said petition was duly signed and acknowledged or proved (sic) by resident taxpayers owning taxable real property aggregating at least one-half of the assessment valuation of all the taxable real property situated in such territory, owned by resident taxpayers, as such valuations appear upon the latest completed assessment roll of said Town of Palmyra.

And whereas a notice in due form containing a description of the proposed fire protection district and specifying the time when and the place where the Town Board would meet to consider the petition and hear all person interested in the subject concerning the same was duly published and posted as required by law.

And whereas pursuant to such notice a public hearing was duly held by said Town Board on November 9, 1943, at 8 o'clock p.m. EWT, at District No. 2 School House, known as East Palmyra School in said Town of Palmyra and within the territory embraced in the proposed fire protection district.

Whereas all person interested who desired to be heard were duly heard and due deliberation having been had, now upon the evidence given at such public hearing and on motion of Kingsley F. Young, seconded by Charles LeBrecht, it is hereby resolved pursuant to Article 11 of the Town Law of NYS that it is hereby determined that it is in the public interest to grant in whole the relief sought by the petition aforesaid; and that it is in such interest that there be and hereby is established a fire protection district within the Town of Palmyra, County of Wayne, NYS, to be known as the East Palmyra Fire Protection District and to be contained in and embrace the following boundaries, to wit: Commencing at a point in the town line between the Town of Marion and Palmyra, which said point is the northwest corner of election District No. 5 of said Town of Palmyra, thence southerly along the west line of said Election District No. 5 to where said line intersects the north bank of the Barge Canal; thence easterly along the north bank of said Barge Canal to the west line of the Town of Arcadia to the northeast corner of the Town of Palmyra; thence westerly along the south line of the Town of Marion to the point and place of beginning. The lines being the present lines of Election District No. 5 of said Town of Palmyra as adopted May 22, 1929, while the south line of said district is the north bank of the Barge Canal. It is further resoled that this Board does hereby find and determine that all the property, property owners, and interested person within the proposed district are benefited thereby and that all property or property owners benefited are included therein.
