September 23, 1999

RE: Ward Cycle Shop Update

Town Board

During the 2 months of August and September, I made several visits to the property at 2858 Rt. 21. My observations were as follows.

I saw approximately 6 or 7 motorcycles parked outside of the garage door on the northwest corner of the building and several vehicles, which I assumed were employee's vehicles, parked at the north end of the building during the month of August.

After the Town Board meeting of August 26, I had a meeting with Mr. Ward to discuss outside storage of customer vehicles.

At no time did I see or hear motorcycles being repaired or tested in the parking lot, nor was I aware of off-hour operations.

Therefore, it is my opinion Ward's Cycle Shop is not in violation of the Special Use Variance conditions. Respectfully submitted, Robert A. Grier Code Enforcement Officer Village and Town of Palmyra

Supervisor Lyon stated that Mr. Grier has inspected this business and apparently Mr. Ward is operating within the parameters allowed by the Town.

Terry Gardner stated that if there are any problems it is the customers that cause them, not the owners.

Mrs. Grasso told the board that she is very disappointed in the outcome of this matter. Supervisor Lyon said that a public hearing was held before a Special Use was granted and that probably would have been the time for her to state her objections.

Dan Gilmore said that this business is not open 24 hours a day, which could be aggravating, and he feels it is time to stop harassing a local businessman.
