On motion of Mr. Ziegler, seconded by Mr. Chapman, was carried: Resolved that the Supervisor be instructed and empowered to transfer the sum of \$927.09 from the Bridge Fund to the Highway Fund and the sum of \$757.07 from the Bridge Fund to the Snow & Miscellaneous Fund.

The matter of increased housing for the road machinery and tools was discussed at length. Also the necessity of procuring more land for the erection of extra housing.

The Town Superintendent then reported that pursuant to advice heretofore received from the Town Board that he had completed the purchase of a strip of land substantially one hundred (100) feet in width lying north of and adjoining the present lands and buildings in the Town of Palmyra used for the storing of its machinery and tools when not in use. That this additional land was necessary for the use of the Town as a site for additional

buildings for the purpose of housing and storing machinery, tools, and implements belonging to the Town and its purchase recommended by him. That to secure the property he had purchased same in his own name and paid to Mr. J. F. Lines of Palmyra, NY, attorney for James L. and Eva H. Holland, the owners of the property, the sum of two hundred twenty-one dollars for purchase price of and attorney's charge on purchase of same. He had now executed deed conveying same to the Town and requested that he be reimbursed for the moneys actually advanced by him in the purchase of the land and presented abstract of title to the property showing that conveyance had been duly made to the Town.

After discussion, the following resolution was duly made, seconded, and unanimously adopted: Resolved that the action of the Town Superintendent in the purchasing for the Town of the parcel of real estate of substantially one hundred (100) feet in width situated in the Town of Palmyra and lying immediately north of and adjoining the lands now owned and occupied by said Town as a site for buildings for the storage of machinery, tools, and implements of the Town and its Highway Department be and the same is hereby approved, ratified, and affirmed as a proper and necessary purchase for the Town, and hereby made the proper act of this Board. It appearing that deed to said property has already been executed, delivered, and recorded placing actual and record title to same in the name of the Town. Bet it further resolved that an order be drawn by the proper officer upon the proper funds payable to H. O. Young to reimburse him for moneys advanced in the purchase of said property for the Town.

Meeting adjourned, and the Board inspected the road on Maple Avenue. H. E. Williamson, Clerk

On motion of Mr. Young, seconded by Mr. Spier, Ira Woodhouse be appointed to act as Truant Officer at \$150.00 per year in the town of Palmyra outside School District No. 1 for the present school year. Carried.

On motion of Mr. Ziegler, seconded by Mr. Spier, that a carload of snow fence be purchased of R. J. Lane Company through Ira Cribb. Carried.

On motion of Mr. Ziegler, seconded by Mr. Chapman, that Mr. S. E. Braman's bill for Compensation Insurance \$464.07 be paid. Carried.

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Tuesday, October 27, 1925(sic). Present: H. L. Averill, Supervisor; W. E. Spier, K. F. Young, L. C. Ziegler, and W. H. Chapman, Justices; and H. E. Williamson, Clerk.

Mr. Whitman of the Lime Manufacturing Company and Mr. Hubbard of the Good Roads Manufacturing Company appeared before the Board show the Lime Tractor for removing snow from roads. Board agreed to go to Ionia to look over the Lime Tractor owned there.

Superintendent of Highways appeared before the Board and was instructed to cut branches of trees extending over roads in different parts of the Town.

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on November 5, 1925. Present: H. L. Averill, Supervisor; L. C. Ziegler, Kingsley Young, W. E. Spier, and W. H. Chapman, Justices. Meeting was called to order by Supervisor Averill.

Miss Lynn Whitman of the Lynn Manufacturing Company, Mr. Hubbard of the Good Roads Manufacturing Company, County Superintendent of Highways Barnes, and Superintendent of Highways Young were present; and the question of purchasing suitable machinery for snow removal was discussed at length. The Board as a Committee of the Whole had inspected the Lynn tractor in use at Ionia, and the following resolution was unanimously adopted:

Resolved that the Palmyra Town Board hereby enters into an agreement with the Lynn Manufacturing company whereby the said Town will procure on the Lease Plan a Lynn Tractor Model 626D with dump body, electric lights, and ice creepers complete at a cost of \$7036, f.o.b., Morris, NY. The rental price to be \$30 per day, and be it further resolved that the town purchase of the Good Roads Machinery Company one Champion V Type Plow with wings for Lynn Tractor at a price fixed at \$1500 less \$275 allowance for No. 10 Champion Blade Plow purchased of Good Roads Machinery Company last winter; and be it further resolved that the purchase of said machinery be subject to approval by the County Superintendent of Highways.
