Town of Palmyra – **1921**

Meeting of the Town Board was held at the Town Clerk's Office on Friday, January 28, 1921. Present: George S. Johnson, Supervisor; L. E. Ziegler, W. H. Chapman, K. F. Young, and W. E. Spire, Justices; and H. L. Averill, Clerk. The meeting was called to order by Mr. Johnson, and minutes of the last meeting were read and approved.

Mr. Ziegler, Chairman of the committee appointed to investigate the proposition of purchasing a tractor for highway work, reported that he and Mr. H. O. Young had looked into the merits of several makes of tractors; but at the present time, he was unable to make any favorable recommendations to the Board.

Mr. Dunn, representing the E & B Tractor, was present at the meeting and asked to be allowed to speak to the Board setting forth the merits of his tractor. He invited the Board to go to Auburn and look the machine over.

Mr. Granger of Lyons appeared before the Board in the interest of the Haiss Loader, and he quoted the price of the machine and gave the Board the specifications and other information relative to the machine.

After a discussion of the tractor and loader propositions, Supervisor Johnson appointed the Board as a committee of the whole to visit Rochester and Auburn at an early date and investigate the merits of the machines sold in those cities and to report at the next meeting.

On motion of Mr. Ziegler, duly seconded, fixing the order of road improvement under the County Highway System in the order of the resolution adopted on October 7, 1920, with provision that the work on No. 1 designation should be commenced at the Brown Farm.

Town Superintendent Young was present at the meeting and reported that the work of gravelling some of the roads in the eastern part of the town in accordance with a contract made for the furnishing of the gravel on a contract basis by residents of East Palmyra residing on some of the highways to be graveled was proceeding very satisfactorily. He asked that the Board authorize the expenditure of about \$1200 additional for about 800 yards more than had at first been arranged for. On motion of Mr. Chapman, duly seconded, the following resolution was adopted:

Whereas an agreement has been made with H. O. Young, Town Superintendent of Highways with W. H. Chapman, Charles Lyon, Abram Orbaker, and --- Hollister. The Town Board concurring to place gravel on certain roads in the eastern part of the Town at the rate of \$1.50 per yard delivered on said highways and properly graded, subject to the approval of said Town Superintendent, be it

Resolved that the Town Board approves the work already finished and that it recommends Mr. Young to make further contracts with above named residents so that an additional 500 yards could be placed on the Oak Ridge Road and the Mander Road under the same conditions and price.

Mr. Johnson stated that as it seemed to be the general opinion of the members of the Board that the purchase of a tractor and a loader for highway work was necessary, he asked that the committee of the whole make a report of their findings as soon as possible after their visit to Rochester and Auburn so that a special meeting of the Board could be called at once to take final action.

No further business appearing, the minutes were read and approved; and the meeting adjourned.

The regular meeting of the Town Board was held at the Town Clerk's Office on Friday afternoon, February 18, 1921. Present: George S. Johnson, Supervisor; K. F. Young, L. C. Ziegler, W. E. Spire, and W. H. Chapman, Justices; and H. L. Averill, Clerk. The meeting was called to order by Mr. Johnson, and minutes of the last meeting were read and approved.

Mr. Johnson asked that the Committee of the Whole report their findings in the matter of the leasing of a tractor, and it was the united opinion of the committee that the Emerson-Brantingham Model 16-32 Tractor be selected at the price of \$2400 f.o.b. Palmyra.

On motion of Mr. Ziegler, duly seconded and carried, the clerk was instructed to call a special meeting of the Board for Tuesday afternoon, February 22 and to ask the Emerson-Brantingham company to have a representative present at the meeting to draw up the necessary base contract covering the purchase of the tractor on the rental plan and to also asks the Bonney supply Company to send a representative down to the meeting, so the matter of leasing a Haiss Loader could be taken up at the same time.

A motion by Mr. Chapman, duly seconded and carried, also instructed the Clerk to notify State Highway Inspector Cribb and County superintendent Sisson of the special meeting to ask them to be present.

On motion of Mr. Ziegler, duly seconded and carried, a resolution was passed asking the Village Board of Trustees to paint the Justice Room and to purchase some new furniture for the same.

Special meeting of the Town Board was held at the Town Clerk's Office on Tuesday, February 22, 1921. Present: George S. Johnson, Supervisor; L. C. Ziegler, W. H. Chapman, W. E. Spire, and K. F. Young, Justices; and H. L. Averill, Clerk. The meeting was called to order by Supervisor Johnson; and on motion of Mr. Ziegler, the reading of the minutes was dispensed with as this was a special meeting.

The Clerk reported that he had received word from State Highway Inspector Ira Cribb that it would be impossible for him to be present but that County Superintendent Sisson was present. Also Fred Dunn of the Emerson-Brantingham Company, and W. D. Bonney of the Bonney Supply Company were present.

Mr. Dunn, representing the Emerson-Brantingham Company, was told that the Board had decided to purchase their Model 16-32 Tractor on the rental basis, and Mr. Dunn was asked to draw up necessary lease covering the same and to submit same to the Board. Mr. Dunn submitted a lease to the members that was entirely satisfactory, and the instrument was made out in triplicate—one being filed in the Town Clerk's Office, one in the County Superintendent's Office, and one for the Emerson-Brantingham Company. The members of the Board and Mr. Dunn, representing the E-B Company signed all three, and the leases were then approved by County Superintendent Sisson. Mr. Dunn stated that the machine would be ordered at once and would probably be received in Palmyra about March 15, 1921.

Mr. Bonney, representing the Bonney supply Company, went into detail regarding the Haiss Loader, and the same met with the approval of the members of the Board and County Superintendent Sisson, both as to equipment and terms. Upon motion, duly seconded and carried, the following resolution was adopted:

Resolved that the Town of Palmyra hereby enters into an agreement with the Bonney Supply Company of Rochester, whereby the said Bonney Company agrees to furnish to the Town of Palmyra on the rental basis one Haiss Loader, Type S-A, self-propelled wagon loader with patented self-feeding propellers at the price of \$1575 f.o.b. New York City. Payments to be made as follows: Twenty (\$20) dollars a day for each day the machine is actually used, the sum of 6 per cent to be paid on all unpaid balances, payments to be made at least once per month. It is also further agreed that the said town of Palmyra shall keep loader insured. Said Bonney company agrees to guarantee the machine against defects in material and workmanship and that it will satisfactorily do the work for which it was recommended.

Mr. Bonney reported that he would order the loader at once and would see that it was properly installed in Palmyra.

The matter of renting a suitable building centrally located for the housing of some of the town machinery was discussed at length. Upon motion, duly seconded and carried, the Supervisor was instructed to appoint a committee of three to investigate the matter with power to act. Mr. Johnson appointed as such committee Messrs. K. F. Young, W. H. Chapman, and W. E. Spire.

The following bill was audited and ordered paid:

Special meeting of the Town Board was held at the Town Clerk's Office on Thursday, March 17, 1921. Present: George S. Johnson, Supervisor, Kingsley F. Young, L. C. Ziegler, and W. E. Spire, Justices. Meeting was called to order by Supervisor Johnson, and minutes of the last meeting were read and approved.

Mr. Johnson stated that the object of the meeting was to make out the Determination and Agreement of Road Work for the coming year. County Superintendent W. G. Sisson and State Supervisor Cribb were present at the meeting and advised the Board in regard to filling out the agreement as follows: Primary Work \$40 per mile for 80 miles

Special Improvements: Commencing at the Marion town line, leading south two miles. Said section is a part of the system as approved under 320A by the Board of Supervisors of Wayne County. Fieldstone for the base will be furnished free in walls and piles. The section is to be graded and drained, and stone base placed this season and finished next year. The Town of Palmyra will provide as its share of construction under 320A the sum of \$5000. The road is to have an 8-inch sub-base, 10 feet wide, 4 inch top of crushed stone, after rolling with a penetration oil top surface 12 feet. It is also agreed that there be left in the hands of the Supervisor as a Reserve Fund \$1696.09.

The report and agreement was signed in triplicate by the Board, and the Clerk was directed to send all three copies to the Highway Department for approval.

A resolution was offered and adopted transferring the sum of \$2500 from the Snow fund to the General Fund, Item One.

The committee consisting of Kingsley Young, W. H. Chapman, and W. E. Spire appointed by the Supervisor to look up the matter of securing a suitable building for the housing of the road machinery asked for an extension of time, and the same was granted.

Mr. Cribb and Mr. Sisson complimented the Town for the work accomplished in the Highway Department and on the efficient and excellent manner that all the highway accounts were handled.

Resolution was adopted asking Mr. Sisson to obtain a copy of the blue print from Division Engineer Atchison of Syracuse relative to the construction of a culvert of concrete on Vienna Street, which is a part of Route 20, and to confer at once with Town Superintendent Young regarding the same so that the Town could begin work at once.

No further business appearing, the meeting adjourned. H. L. Averill, Clerk

Regular meeting of the Town Board was held at the Town Clerk's Office on Tuesday, March 29, 1921. Present: George S. Johnson, Supervisor, L. C. Ziegler, K. F. Young, W. H. Chapman, and W. E. Spire, Justices, and H. L. Averill, Clerk. The meeting was called to order by Supervisor, and minutes of the last meeting were read and approved.

The committee appointed to investigate the proposition of proper housing for the road machinery reported that after careful consideration and investigation, the committee recommended the remodeling of the present town building on Kent Street to such an extent that all the road machinery could be housed there. The committee also recommended that work on the building should be commenced in the fall.

Town Superintendent Young was present and gave an outline of the road work done since the last meeting. Mr. Young stated that the E & B Tractor recently purchased had been given a thorough test and had proved very satisfactory in every way. He stated that he had already graded and finished 27 miles of highway showing that the tractor was capable of doing about eighteen miles of road work a day. Mr. Young reported that he was paying 35 cents an hour for common laborers; 40 cents an hour for machine men and drivers; and 50 cents an hour for foremen. Mr. Young said that he could do twice as much work on one day with the tractor as he could with a steam outfit and the same force of men.

Supervisor Johnson read a letter, which he had received from the State Highway Department; and on motion, the Clerk was instructed to spread the communication on the minutes, and the same follows:

Mr. Dear Sir:

We are in receipt of a report from District Supervisor Ira P. Cribb, which shows a distribution of the expenditures incurred for highway purposes in the Town of Palmyra during the year 1920; and I only wish that every supervisor in the state could have the pleasure of reading the same.

It is very gratifying that a supervisor has given the time necessary to compile such a comprehensive report as you have made of the distribution of the expenditures of highway moneys in the Town of Palmyra.

I am returning the report to Mr. Cribb, so that he may use it as an example to the various supervisors in his district when occasion permits.

Young, Justices, and H. L. Averill, Clerk. Meeting was called to order by the Supervisor, and the minutes of the last meeting were read and approved.

Town Superintendent Young was present at the meeting and made his report on road work. Mr. Young stated that an engineer representing Division Engineers' Office at Syracuse. County Superintendent Sisson had looked over the blue prints showing construction necessary on the culvert on Vienna Street. Mr. Young was of the opinion that some of the expense entailed in carrying out the provisions in the blue print could be saved owing to the engineers' opinion that certain portions of the culvert would not have to be rebuilt.

Regular meeting of the Town board was held at the Town clerk's Office on Friday, November 25, 1921. Present: George S. Johnson, Supervisor; L. C. Ziegler, W. E. Spire, W. H. Chapman, and K. F. Young, Justices; and H. L. Averill, Clerk. Meeting was called to order by Supervisor Johnson, and minutes of last and adjourned meetings were read and approved.

Mrs. F. E. Rowley and Miss Elizabeth Eaton appeared before the Board in the interest of a town nurse to be appointed by the Town Board at a salary of \$1800 a year. Said salary to be assessed against the Town and paid for by a tax against the property holders of the town. Both Mrs. Rowley and Miss Eaton spoke at length in favor or the project. After a general discussion by the Board, it was the unanimous opinion of the members that before any action could be taken on the matter in any way, an opinion would have to be obtained from the Attorney General as to whether the Town Board had the right to create such an office as Town Nurse. The Clerk was instructed to communicate with the Attorney General's Office and report the decision at the next meeting, at which time further action could be taken on the proposition.

The matter of justices' fees as relating to the Town and Village was taken up and discussed at length. On resolution, duly carried, K. F. Young and L. c. Ziegler were appointed as a committee to investigate the law on the subject with Attorney George S. Tinklepaugh and report at the next meeting.

Town superintendent H. O. Young was present at the meeting and gave the board an outline of the work he intends to do in December if the weather conditions were favorable. Amount the other things Mr. Young contemplated doing was the gravelling of certain sections of the East Palmyra Road, and this met the approval of the Board.

Annual Town Settlement Day for the Palmyra Town Board was held at the Town Clerk's Office on Wednesday, December 28, 1921. Present: George S. Johnson, Supervisor; L. C. Ziegler, W. E. Spire, W. H. A resolution was passed authorizing the Supervisor to transfer the sum of \$1500 from the General Town Fund to the General Highway Fund and \$500 from the General Town Fund to the Special Highway Fund.

A resolution was passed increasing the salary of the Town Clerk \$125.00 per year beginning with January, 1922.

The following resolution was offered by Mr. Ziegler and was unanimously adopted:

Whereas at a meeting of the Town board held on august 30, 1921, George G. Throop was re-appointed to the office of Truant Officer at a salary of \$100 a year; and after being notified of said re-appointment, Mr. Throop declined to serve for the stated compensation, and his appointment was therefore never accepted. Be it hereby resolved that the resolution of August 30, appointing Mr. Throop be and the same is hereby amended insofar as the compensation is concerned, and that the compensation for Truant Officer be set at \$150 a year.

On motion of Mr. Kingsley Young, a resolution was passed authorizing the Supervisor to appoint a committee to confer with the Buffalo-Pitts Steam Roller Company in regard to the purchase of a new steamroller and to report at the next meeting. That said committee be also empowered to take up the matter of purchasing a new motor truck and report at

some future meeting. Mr. Johnson appointed Mr. Averill and Mr. Ziegler as such committee.
