## REGULAR MEETING OF THE TOWN BOARD PALMYRA TOWN HALL December 28<sup>th</sup>, 2023

At 7:00 p.m., Supervisor Gary Rose called to order the regular Town Board meeting, scheduled for Thursday, December 28<sup>th</sup>, 2023, at the Palmyra Town Hall, 1180 Canandaigua Rd, Palmyra, New York.

Supervisor Rose led those present in the Pledge of Allegiance to the Flag.

Upon roll call, the following Board members were present:

Motion was made by Todd Pipitone to approve the minutes of the Town Board meeting which took place on November 21<sup>st</sup>, 2023.

Mike Catalano, our representative from the Wayne County EMS Advisory board, was unable to attend.

### **COMMUNICATIONS RECEIVED**

## Supervisor Rose received the following email from Gigit Graham, Liberty St, on December 6<sup>th</sup>, 2023:

"Hi Gary,

I was wondering what became of the leaf pick up on maple, meadow, Bonnie Brae. As was discussed at the meeting with Tracy and myself back in October, you had said there is no leaf pick up in the town. We addressed with you the situation with maple and meadow etc. you said you would look into it. Well I see that you are still picking up on those roads. How is this fair to the other taxpayers in town that do not get this service. How do you justify this. Please explain how and why this is allowed.

Thank you Gigit Graham"

Supervisor Rose wanted to take this opportunity to ask the board to give their thoughts on this situation. It was explained that this practice of picking up yard debris on Maple Ave (town) was put in place in 2005 to help offset a labor imbalance between the town and village. Much discussion ensued, and there were three choices that Supervisor felt were available. First, to carry on as is (though the board did not find this fair to the taxpayers), second, to stop entirely (again not the fairest if you lived on that road and had this service for years), or lastly, to perhaps open a week in the spring, and a week in the fall for whole town pickup by appointment. It is felt that this last option could still allow for offsets of labor hours.

Supervisor Rose will speak to Mayor Husk to get his thoughts, and this topic will be revisited at the January 25<sup>th</sup>, 2024 meeting.

## The Town Clerk received the following email from Marc Carrier, Garnsey Rd, on December 27<sup>th</sup>, 2023:

"Garnsey rd. neighbors are concerned for the current state of the property and would like an update being the minimal cap which was, has now become incredibly breached along with air quality hazards, as a number of these concerns have been shared by Mr. Hagar and Mr Vascukynas who reached out to Sup. Rose

Thank You Marc Carrier"

Supervisor Rose said he would address this topic in his monthly report following.

### The Town Clerk received the following email from Linda Tynon, Floodman Rd, on December 27th, 2023:

"To: The Town Board of Palmyra, NY

We are at the beginning of an eventful season for tourism in Palmyra. In preparation for the solar eclipse as well as our exciting summer events, please consider the opportunity to expand our capacity for hosting a wider variety of quests to Palmyra.

We are fortunate to be a tourist destination in the heart of the Fingerlakes, on the Erie Canal hike/bike trail and at the foundation town of the Mormon religion.

Resident property owners of neighboring towns are currently available to host campers as short-term guests. Although a specific segment of tourism, the economic impact to our neighboring communities is significant.

In an effort to promote tourism in Palmyra, I request the opportunity to explore the possibilities of also allowing Palmyra property owners to host travelers (with self-contained RV's/campers) as their guests, without charge, for designated short term visits.

The economic impact alone would be significant as more campers would eat, shop, and explore Palmyra. I would welcome the opportunity to bring these facts to you at a future date for your consideration.

### **PUBLIC INPUT**

**Linda Tynon, Floodman Road**, with regards to the letter submitted above.

Ms. Tynon addressed the board regarding the letter that she submitted and the proposal she had with regards to promoting tourism in Palmyra. She explained that as the code is written now, the community is not allowed to host campers (stay in campers/ RV's) on their property. She is hoping that something could be done to allow friends, family, or guests to park 2-3 days on properties, so they fully take advantage of the shopping, eating, and spending money in Palmyra.

Supervisor Rose explained that typically the board would like a recommendation from the Planning Board and referred her to Code Enforcement to arrange a meeting. He also reiterated that though the town board might be open to this concept, this was in no way a blessing. He stated that there is much more to look at and review with code, neighbors, etc.

For public hearings, speaking will be limited to topics on the agenda.

### REPORTS OF STANDING COMMITTEES

### Supervision---Animal Control, Historian, Finance: Gary Rose, Chairman

- 1. Mr. Rose began a discussion regarding optional coverage & quotes with regards to our insurance coverage on crime, vehicles, and cyber liability. He explained we are switching from NYMIR to CFC for cyber security, as our policy was cumulative. This meant if we had numerous problems in one year, we could top out. Also, the trucks were thought to be undervalued to repair or replace if necessary. After discussion with the board, it was felt that though there is a slightly higher premium to upgrade our coverage, the coverage would be much better, and we would still be \$1,600.00 under the budgeted amount for 2024.
- **2. Garnsey Rd Update:** Though the deadline date for the final approval to submit the plan to DEC was December 31<sup>st</sup>, our engineers requested an extension until January 31, 2024, which was granted. The engineers had been out to dig test holes, and air quality was measured and sent to the DEC. Councilman Cook noted that the DEC has been involved in the whole project, and that LaBella gives them constant updates and are kept abreast of all that is being done. The DEC has also been more than happy with our highway department and their diligence in this process. The DEC will determine our next steps at that time.

Public Works: Highway Department, Equipment and Facilities Councilman James Welch

### 1. Highway Department report for December:

### HIGHWAY SUPERINTENDENT REPORT FOR TOWN BOARD MEETING 12/28/23

Since the 11/21/23 Town Board meeting we have completed the following work:

 Plowing/Sanding —To date this winter season we have made 9 trips out of the barn.

A comparison to this point of the past 5 winter seasons is below:

#### REGULAR TOWN BOARD MEETING

- o December 2022 10 trips
- o December 2021 12 trips
- o December 2019 32 trips.
- o December 2018 31 trips.
- Salt Orders So far for the month of December we have ordered 200 tons of salt. For the winter season we have received 206 tons of our 2500-ton allotment, or approximately 8% of our allotment.
- **Snow Fence** On 12/14, we were finally able to install most of our snow fence.
- **Brush Mowing/Tree Work** This month we completed brush mowing on Hazen Lane, Vault, S.Creek, Hogback and Floodman Roads. We plan to continue as the weather permits.
- Fleet Maintenance We continue with general maintenance on the entire fleet after each plow run. We will soon start to bring in various 'summer'-related pieces of equipment for their annual servicing and maintenance work.
- Personnel Over the past 3 months we have gone through both a Part-Time and a Full-Time application process. We held interviews on 12/12 and I'm excited to request permission to hire Kiel Hansen, who lives here in Palmyra, for Full-Time employment with the Town.
- **Tires** On 12/8 and 12/12, we recycled over 120 tires with Nucor Recycling in Auburn. This free tire recycling was organized through Wayne County Soil & Water. We are still hoping to deliver another 60-90 tires sometime soon.
- Garnsey Road Landfill Project From 11/28 to 11/30 we completed test hole digs with LaBella Associates staff to assist with the site investigation and survey work.
- Sanitary Sewer Project Update Villager Construction is currently prepping the drill pad at the WWTP site. Turner Underground will start the Canal crossing in the coming week or so, which I understand could take approximately 6 weeks. Their pipe install crew is finishing up in Walworth and will soon start installing air relief manholes on Oneil Road and Quaker Road.

Any questions, comments or concerns I will be glad to answer.

Mr. Boesel stated that he is working on prioritizing projects to use the SAM Grant as the deadline is in 2025. He has also been speaking to CEO Pat Sheridan regarding a new "driveway application" process, and formalizing & using the neighboring towns fee schedules. Councilman Cook added that he is speaking to Chris Lyon about what will be done with the Palmyra Gravel pit.

## Human Services: Town Clerk, Archives, and Town Hall Facility Councilman Bradley Cook

- 1. Town Clerk Report for December: I will combine a full report for December in January.... but for now, a few highlights this month include:
- \* I had a meeting with the animal control officer, and we sent out final letters to people that have not renewed their dog licenses. Those that do not renew by January 31, 2024, will receive a court appearance ticket.
- \*After approval for credit card acceptance this evening, I can set up a meeting to integrate it into our office for payment for everything EXCEPT tax payments,
- \*Taxes, taxes, taxes. Heidi J. and I picked up taxes from county and metered the postage there (they have a much better, high volume postage meter). We are now in the midst of sorting all the bills so they could be mailed on Friday December 29, 2023, as we begin collecting on Tuesday.

TAKE FURTHER NOTICE that taxes may be <u>paid</u> on or before February 2, 2024 <u>without charge or interest</u>. On all taxes received after such date, there shall be <u>added interest of 1% if paid on or before March 3, 2024</u>, and an <u>additional 2% on or after March 5, 2024</u>. The last day of Town/County tax collection will be March 31, 2024.

TAKE FURTHER NOTICE that Town/County taxes may be paid in two installments, with the first half paid on or before February 2, 2024 without charge or interest. If the second installment is paid between February 3, and March 4, 2024, there shall be added interest of 1% on the remaining amount. If the second installment is paid between March 5 and March 31, 2024, there shall be added interest of 2% on the remaining amount.

FURTHER NOTICE IS GIVEN that there will be a \$20.00 fee for all returned checks.

3. Building Update: Airquip Heating & Cooling was in for our winter cleaning and filter changes. There were no issues, and all is working fine. In January, I will call to line up for a spring /summer visit. The locks, including the kennel and back kitchen door, are now all finally finished. I hope! We will begin reviewing & prioritizing town hall projects in January.

## Town Development: IT & Phones, Fire Protection Contracts, and Strategic Plans - Councilman Todd Pipitone

**1. Comprehensive Plan:** There was a monthly zoom meeting of the town & village facilitators on December 22<sup>nd</sup>. Councilman Pipitone attended live, and the town clerk talked with MRB ahead of time. The board packets contain a summary of what has been happening with the comprehensive plan. There will also be a link on our website regarding the Comprehensive Plan information, complete with survey. We asked the public to visit the town & village websites (Comprehensive Plan links), and to please provide some insight as to what they envision for our community in the future. The survey will not take long and is directly linked to MRB to process. As soon as the village is also ready, we will put this on our Facebook pages as well.

Government Operations: Assessor, Youth & Aging, Code Enforcement/Planning Board, and Justices - Councilman Doug DeRue

### 1. Assessor's Office Report for December:

REPORT TO THE TOWN BOARD FROM THE ASSESSOR'S OFFICE December 22, 2023

New York State has made changes to how income is calculated for the Senior Citizen Exemption. It is a bit more complex than in the past. In the past we were directed by the state to <u>include</u> Veteran's disability payments and Workers Compensation payments and they no longer count as income for the purpose of this exemption application.

For those reporting Capital Gains or other income losses, we are required to document them in categories and each category has a cap of \$3,000 for a Max of \$15,000 in claimable losses for the purpose of this exemption.

Pal-Mac school has increased their Income threshold from \$26,900 to \$37,400.

Letters were mailed to residents with this year's renewal as well as an income worksheet for residents that file income taxes, an income worksheet RP-467-Wkst for residents that do not file Income Taxes, and a **Documents Needed Form.** 

While I understand this is all very complicated, the easiest thing for them to do is gather the requested documents listed on the form and stop in the office and we will help sort it out and make copies of the required forms.

We are receiving a fair number of Senior applications back into the office without proof of income and we cannot process without copies of **2022** Income.

Farm Exemptions were mailed after a review of some prior years data. For those residents whose lease is expiring soon we sent a new lease form. There were also a few farmers who we requested income verification from as well.

I have been working on recording on a spreadsheet all the Palmyra sales for 2023 from January to November. I am reviewing the MLS and comparing inventory and permits and adding value as appropriate for the updated inventory and permits.

On 12/12, I attended the Wayne County Assessors Association meeting in Lyons.

We have processed the November sales. 4 Village and 7 Town sales. There is 1 Parcel split and 2 Parcel merge. requests.

### **GENERAL INFORMATION**

## The following email was received on Friday 12/22/23, from NYS regarding elections:

"This evening, Governor Hochul signed legislation that changes election years for most town and county positions from odd to even years to coincide with national and statewide elections. Please note this law does not impact the term of office for anyone elected in November 2023. Below is an FAQ on the law.

### What does \$3505B/A4282B do?

Among other things, it changes election years for town positions, except for town justices, and various county positions from odd-numbered years to even-numbered years. The reasoning behind the switch is to increase voter turnout in local elections.

### Why switch election years?

The stated purpose of the law is to increase voter turnout in local elections. Some towns already have elections in even years and therefore this bill will not impact them.

### How will the switch to even years take place?

As stated, if you were elected in 2023, you will serve your full term. In order to transition to even years, there will also be town elections in 2025 and 2027; however, one year will be taken off the term of office, for one time only. For example, if you have a two-year term of office and ran in 2023, you will serve your full two years. If you choose to run again after completing your term, there will be an election in 2025 but it will be for a one-year term, and you will have to run for re-election in 2026. If you have a four-year term of office and ran in 2023, you will serve your full four years, and if you decide to run for reelection, you will run at the 2027 election; however, it will only be for a three-year term. Then, in 2030, the term of office will return to four years.

### Why aren't all local elections / all positions changed to even years?

Some positions, like town justices and county judges, have constitutional provisions that come into play and there would need to be an amendment to the

New York State Constitution to switch those elections to even years. A constitutional amendment would also be required for city elections, and therefore they are not included in the legislation. Finally, villages are not included as they have a different election cycle and conduct elections themselves.
