Town of Palmyra Minutes for 1923

Meeting of the Palmyra Town Board was held at the Clerk's Office on Saturday, January 6, 1923. Present: George S. Johnson, Supervisor; W. H. Chapman, L. C. Ziegler, K. F. Young, and W. E. Spire, Justices; and H. L. Averill, Town Clerk. The meeting was called to order by Mr. Johnson, and the minutes of the last meeting were read and approved.

Mr. Johnson stated that the first business to be taken up at the meeting would be the appointment of an assessor to fill the unexpired term of Mr.Christopher Belty, whose death occurred on January 1, 1923.

Mr. Young proposed the name of Arie Task to fill the unexpired term of the late Mr. Belty. On motion of Mr. Young, seconded by Mr. Spire the following resolution was unanimously adopted: Whereas a vacancy exists in the office of Assessor in the Town of Palmyra, county of Wayne, because of the death of Christopher Belty, who was elected to such office on November 6, 1919, for a term of four year from January 1, 1920.

Now therefore, in pursuance of the power vested in us by Section 130 of the Town Law, we the members of the Town Board of such town do hereby approach Arie Task of said town to fill the vacancy existing in such office of Assessor. The said Arie Task shall hold such office until the December 31, 1923. Until his successor is elected or appointed and is justified by law.

The Clerk was instructed to file a notice of such in the records of his office and to notify Mr. Task of his appointment.

On motion of Mr. Ziegler, the following resolution was adopted, and the Clerk was instructed to spread the same on the minutes of this meeting: Whereas it has pleased almighty God in his infinite wisdom to call from our midst on January 1, 1923, our esteemed friend and associate Christopher Belty, who has served the Town of Palmyra well and faithfully as Assessor for the past nineteen years, and who always had the welfare of the Town at heart, be it

Resolved that in the death of Christopher Belty, the Town of Palmyra not only loses a valued official but the entire community loses a man in who the utmost confidence could be placed. No matter with what task he was entrusted with, he could always be relied upon to do his full duty; and be it further

Resolved that as an expression of our sympathy and sorrow the Clerk be instructed to send a copy of these resolutions to the bereaved widow and family and to have a copy spread upon the minutes of this Board

The resignation of Mr. Thomas L. Cook as Assessor was then read to the Board by the Clerk. Mr. Cook, stating in his formal communication to the Board that will health

would prevent him from filling the duties of the office. On motion of Mr. Spire, seconded by Mr. Chapman, the resignation was accepted.

On motion of Mr. Young, seconded by Mr. Averill, the following resolution as unanimously adopted: Whereas a vacancy exists in the office of Assess in the Town of Palmyra, County of Wayne, because of the resignation of Thomas L. Cook, who was elected to such office on November 6, 1921, for a term of four years from January 1, 1922.

No therefore in pursuance of the power vested in us by Section 130 of the Town Law, we the members of the Town Board of such town, do hereby appoint Louis C. Ziegler of said town to fill the vacancy existing in such office of Assessor. Said Louis C. Ziegler shall hold such office until December 31, !925, or until his successor is elected or appointed, and he is qualified as provided by law. The Clerk was instructed to file a copy of Mr. Ziegler's appointment in the records of the Town and to notify him of such appointment

Mr. Spire stated that owing to Mr. Cook's long and faithful service to the Town as Assessor, he would introduce the following resolution. On motion of Mr. Spire, seconded by Mr. Young, the following resolution was unanimously adopted:

Whereas Thomas L. Cook, having resigned his office of Assessor on account of poor health, we the members of the Palmyra Town Board do hereby adopt the following resolution: Resolved that we desire to thank Mr. Cook on behalf of the Town of Palmyra for his long and faithful service as Assessor. We sincerely regret that the condition of his health is such that he feels that it would be impossible for him to longer look after the duties of that office. We not only thank him for the great service he has been to the Town during all the years he has so faithfully serviced its people; but we also wish to express our thanks to him for the many favors he has bestowed upon us as a Town Board, and be it further resolved that a copy of these resolutions be spread upon the records of this Town, and that a copy of them be sent to the retiring Assessor.

The Clerk then read the resignation of Supervisor George S. Johnson, who was elected member of Assembly from Wayne county at the last general election. On motion of Mr. Ziegler, seconded by Mr. Chapman, the resignation was accepted. Mr. Johnson asked the Clerk to take the chair and asked the Board to appoint his successor at the meeting.

Mr. Chapman placed the name of O. Clate Silver in nomination for the appointment of Supervisor, and the nomination was seconded by Mr. Ziegler. The following resolution was unanimously adopted: Whereas a vacancy exists in the office of Supervisor of the Town of Palmyra, county of Wayne, because of the resignation of George S. Johnson, who was elected to such office on November 8, 1921, for a term of two years from January 1, 1922.

Now therefore, in pursuance of the power vested in us by Section 130 of the town Law, we the members of the Town board of such Town do hereby appoint O. Clate Silver of said Town to fill the vacancy existing in such office of supervisor. The said O. Clate

Silver shall hold such office until December 31, 1923 and until his successor is elected or appointed and has qualified as provided by law.

The Clerk was instructed to notify Mr. Silver of his appointment at once and to file such appointment in the records of this office.

Mr. Silver took the oath of office at once, filed his acceptance, and took the supervisor's chair. Mr. Johnson outlined the duties of the office to Mr. Silver, and the work that was already progressing and turned the books, papers, records, and monies over to him.

Mr. Silver's first duty as Supervisor was approving the Collector's Bond. The following resolution was unanimously adopted:

Whereas George S. Johnson having resigned his office as Town of Palmyra Supervisor on account of his having been elected to the Assembly from Wayne County, we the members of the Town board os said Town do hereby adopt the following resolution:

Resolved that we desire to commend Mr. Johnson officially for his marked ability displayed while discharging the duties as Supervisor. We would thank him for his uniform courtesy shown toward all with whom he has come in contact, and also for special favors received by us at this hand. We regret that we are to be deprived at our future meeting of his genial presence.

Resolved that we congratulate Mr. Johnson, Town of Palmyra, and the County of Wayne on the fact of his having been elected to the Assembly.

Resolved that the above resolutions be presented to the retiring supervisor, and a copy thereof spread upon the records of the Town of Palmyra.

The matter of steel filing cases for the Clerk's Office was discussed. The Clerk was authorized to purchase additional equipment at a cost of about \$45.00.

Meeting of the Palmyra Town Board was held in the Clerk's Office on Tuesday, January 23, 1923. Present: O. Clate Silver, Supervisor; L. C. Ziegler, W. E. Spire, W. H. Chapman, and K. F. Young, Justices; and H. L. Averill, Clerk. The meeting was called to order by Mr. Silver, and the minutes of the last meeting were read and approved.

The highway bonds of the Supervisor in the amount of \$30,500 were submitted to the Board, and the same were approved. The Clerk was instructed to send the four copies of the bond to the Highway Department for approval.

On motion of Mr. Ziegler, seconded by Mr. Chapman, a resolution was passed designating the Supervisor, the Town Clerk, and the Town Superintendent of Highways

as a committee to represent the Town at the annual officials meeting in Albany on January 30 and 31.

Town Superintendent Young was present at the meeting and submitted a copy of a letter written to Miss Dorothy Jeffers, RFD 2, Newark, by the State Highway Department relative to the condition of a highway leading to a school taught by Miss Jeffers caused by the heavy snow. The letter was read by the Clerk and ordered spread upon the minutes. The letter follows:

Dear Madam:

I have your letter of the 11th instant regarding the removal of snow along the highway in the Town of Palmyra leading to the school in which you teach.

The law provides that it is the duty of the Town Superintendent to remove the snow along the highways, that is insofar as the funds will permit as provided by the Town Board. This department has no jurisdiction in the matter other than to see that the Town Superintendent fulfills the duties of his office. I am sending a copy of this letter to the Supervisor George S. Johnson, Palmyra, and would advise that you communicate with him and the other members of the Town Board.

In ordinary storms the removal of snow meets with the satisfaction of all persons concerned, but where there are such frequent and heavy storms such as we have had all over this state during the past week or ten days, it is almost impossible to keep the roads open to traffic with the funds. However, I believe that the Supervisor will take this matter up with the members of the Town Board and Town Superintendent of Highways to the end that conditions may be improved in your vicinity. Meeting of Palmyra Town Board was held at the Town Clerk's Office on Tuesday, February 27, 1923. Present: O. Clate Silver, Supervisor; L. C. Ziegler, W. H. Chapman, W. E. Spire, and K. F. Young, Justices, and H. L. Averill, Clerk. The meeting was called to order by Mr. Silver, and the minutes of the last meeting were read and approved.

Mr. Curtin and Mr. Kitchen, representing the Brockway Truck Company, were present and went into detail regarding its Brockway Truck and quoted prices, etc.

A resolution was passed authorizing the Supervisor to appoint a committee to investigate the proposition of purchasing a new truck for the Town. The Supervisor named Mr. Ziegler and Mr. Averill as such a committee to act with the Town Superintendent, H. O. Young.

The matter of the purchase of additional filing equipment for the Town Clerk's Office was discussed. A resolution was passed authorizing the expenditure of the sum of

\$155.60 in addition to the resolution of December 31, 1922, authorizing the expenditure of \$45.00

A communication was received from Town Historian, A. S. VanAlstine, stating that he was compiling a war record of the Town and that the same would be ready to submit to the Board at an early date.

Town Superintendent Young was present at the meeting. He stated that he had received many complaints about the country highways not being kept open, but he reported that it would have been a physical impossibility to have kept the country roads open for motor traffic this winter. He was making arrangements to open a good many of the roads as soon as the weather became settled, and the spring thaws come.

Special meeting of the Town Board was held at the Town Clerk's Office on Saturday, March 10, 1923. Present: O. Clate Silver, Supervisor; L. C. Ziegler, W. H. Chapman, K. F. Young, and W. E. Spire, Justices; and H. L. Averill, Clerk. The meeting was called to order by Mr. Silver, and the minutes of the last meeting were read and approved.

Mr. W. H. Dixon, representing the Palmyra Grange, appeared before the Board in the matter of a proposed fire district outside the Village of Palmyra for the protection of property from fire loss; but the matter was laid on the table pending further information.

L. C. Ziegler, representing the committee to obtain information and prices regarding the purchase of a motor truck, reported that several trucks had been investigated thoroughly as to price, quality, etc and that in the committee's judgment, the GMC seemed to the best suited for the work demanded of the truck. The price was also lower than any of the other trucks examined. The committee recommended the purchase of the GMC truck. A resolution offered by Mr. Chapman, seconded by Mr. Spire, was unanimously adopted authorizing the Clerk to draw up the necessary papers for the purchase of the truck on the following basis: GMC truck \$3500; allowance on Acme; \$800 cash balance = \$2700.

On motion of Mr. Ziegler, seconded by Mr. Young, the resolutions on the death of Constable W. H. Dennis were passed, and the Clerk was instructed to send a copy of the same to the family.

Whereas it has pleased Almighty God in his infinite wisdom to call from our midst on March 6, 1923, our esteemed friend and fellow town official, William Henry Dennis, who has served the Town of Palmyra most efficiently for upwards of a quarter of a century as Constable, and who always had the best interests of the Town at heart.

Be it resolved that in the death of William Henry Dennis, the Town of Palmyra loses one of its most valued officials, and the entire community loses a man who always stood ready and willing to give his most efficient service in the duties of his office.

And be it further resolved that as an expression of our sympathy and sorrow, the Clerk be instructed to send a copy of these resolutions to the bereaved wife and family and to have a copy spread upon the minutes of this Board.

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Wednesday, March 28, 1923. Present: O. Clate Silver, Supervisor; L. C. Ziegler, W. H. Chapman, W. E. Spire, and K. F. Young, Justices; and H. L. Averill, Clerk. Meeting was called to order by Supervisor Silver, and the minutes of the last meeting were read and approved.

John W. Rushmore, Jr., representing the Hickey Post American Legion, appeared before the Board and asked that consent be given the Legion to make some extensive repairs and improvements to the old cemetery on Church Street, which is the burial place of General John Swift, one of the first settlers of Palmyra. On motion of Mr. Ziegler, seconded by Mr. Chapman, a resolution was passed giving the Legion such consent.

A communication was received from Arie Tack, who was appointed to the office of Assessor on January 6, 1923, to fill the unexpired term of C. Belty, deceased, stating that he would be unable to fill the office. On motion of Mr. Chapman, seconded by Mr. Spire, a resolution was passed appointing Carlton H. Hedden to the office of Assessor to fill the unexpired term of C. Belty, deceased. The Clerk was instructed to file the resolution of such appointment on the records of his office and to notify Mr. Hedden of his appointment.

On motion of Mr. Ziegler, seconded by Mr. Young, a resolution was passed appointing Henry C. Hilborn to the office of Constable to fill the unexpired term of W. H. Dennis, deceased. The Clerk was instructed to file the resolution of such appointment in the records of his office and to notify Mr. Hilborn of his appointment.

On motion of Mr. Chapman, seconded by Mr. Young, a resolution was passed appointing C. Henry Harrison as a Constable to fill the vacancy in the East Palmyra District caused by the non-qualification of Isaac O'Meal, who was duly elected to such office on November 10, 1921. The Clerk was instructed to fill such resolution of appointment on the records of his office and to notify Mr. Harrison of such appointment.

A resolution offered by Mr. Spire, seconded by Mr. Chapman, was passed authorizing the supervisor to transfer from the General Town Fund to the Machinery Fund the sum of \$2700 for the payment of the new GMC truck.

- 1. It is agreed that we hereby set aside for primary work and general repairs upon the highways including sluices and culverts an average sum of \$50 per mile for 80 miles.
- 2. Special Improvements
 - A. On the road commencing at Marion Town Line and leading to Palmyra Village Line, a distance of two miles there shall be expended the sum of \$5000. Type: Macadam top and penetration 12 (feet?) wide of surface material 4 inches thick. Sub-base 10 feet wide and 8 inches thick.
- 3. It is also agreed that there be reserved in the hands of the Supervisor the sum of \$6094.43.

Adjourned meeting of the Town Board was held at the Town Clerk's Office on May 11, 1923. Present: L. C. Ziegler, W. H. Chapman, W. E. Spire, K. F. Young, Justices; and H. L. Averill, Clerk. Owing to the absence of Supervisor Silver on account of serious illness, the Clerk called the meeting to order. L. C. Ziegler was chosen Chairman, and the minutes were read and approved.

Town Superintendent Young was present and stated that he had received bids on crushed stone for 1923 from several firms; but the price given by the Geneva Stone Corporation at \$1.20 per ton for Nos. 1, 2, and 3 stone was the lowest. On motion of Mr. Chapman, seconded by Mr. Spire, a resolution was passed authorizing the Town Superintendent to enter into an agreement with the Geneva Stone Company at the above figure for whatever crushed stone was needed for highway work in 1923.

On motion of Mr. Young, seconded by Mr. Spire, a resolution was passed authorizing the transfer of \$992.70 from the General Town Fund to the General Highway Fund to reimburse 320A money for balance in year 1921 used and expended in general highway work.

Superintendent Young stated that engineers from the Genesee Bridge Company of Rochester had made examination of the Pliny and the East Palmyra bridges for repairs in accordance with the provisions of the State Department and that they would submit figures to the Town as soon as possible on the work. Mr. Young reported that the Olean Bridge Company had already furnished figures in the amount of \$3000 for the work.
