They have run into many problems in trying to upgrade, remodel or finance their current home due to its age and construction. They propose to demolish the current

structure and bring in a new 28' by 60' manufactured home, to be placed on a slab with a four-foot crawl space. The new home would be moved 15 feet further away from the lot line. The construction of the new home would increase their living space and enjoyment of the property. They acknowledge the property assessment would increase accordingly, and are satisfied.

Supervisor Lyon asked for any comments either for or against this application. Jim Scarfia identified himself as a neighbor across the street, and spoke in favor of the application. Allyn Cator, property owner contiguous to the Motts, said he had no problems with the plan. Councilman Nussbaumer commented that upgrades to property are always great to see.

CEO Grier stated the building permit for this project would be subject to standard side setbacks, and that since it is a local matter, there are no recommendations necessary from the Planning Boards.

WHEREAS, the Town of Palmyra has not previously had to issue bonds for the acquisition of Town property, either real or personal, and

WHEREAS, the Town of Palmyra has acquired a new Town Hall which will have a bonded indebtedness, and

WHEREAS, the Town of Palmyra desires to establish a Reserve Fund for the payment of the bonded indebtedness pursuant to §6-h of the General Municipal Laws of the State of New York.

NOW, THEREFORE BE IT RESOLVED that the Town Board does hereby establish a Reserve Fund for the payment of bonded indebtedness of the Town of Palmyra. This fund may not be used for the payment of any indebtedness which is payable from assessment upon an area in the Town which is smaller than the total area of the Town.

Expenditures from this Reserve Fund may only be made by an appropriation pursuant to a resolution of the Town Board and only for the payment of the principal and interest on bonds issued by the Town of Palmyra having a maturity of not less than five years, or for the purchase of bonds of the

Town of Palmyra having a maximum maturity of not less than five years at a price not to exceed the par value and accrued interest to the date of delivery of said bonds or if the bonds were issued subject to redemption, the fund may be used to redeem bonds prior to maturity.

The funds in this Reserve Fund may not be used for the payment of bonded indebtedness where a provision is made in the event budget for payment of the principal and interest on the bond.

The Town shall comply with and proceed pursuant to §6-h of the General Municipal Laws of the State of New York.
