AGENDA ITEMS

1. Approve: Additional Cameras for Town Hall: Todd Pipitone made a motion to approve the purchase of two additional security cameras through Barringer Electronix, not to exceed \$2,266.00. This includes all equipment necessary as well as labor.

2. Items to be discussed:

Water and Sewer Collection: The WCWSA Authority sent a letter to the Towns of Palmyra, Macedon and Marion, and strongly suggests that all towns stop collecting water and sewer payments after December 31, 2025. The Town Clerk would like to continue collecting if the WCWSA allows, and the Town Supervisor does not mind either way as long as all money is processed through the Town Clerks office. The Town Board will make a final decision at the next regular meeting.

2026 Budget: Rebecca Wetherby was in attendance to aid in further discussion of the 2026 Budget that was prepared with the numbers earlier provided by the department heads and then with amounts that were discussed further by the board. A round-table-open general discussion once again ensued in the Town Hall dining room area.
