At a price of \$3200.00 payable by the issuance of Certificates of Indebtedness in the denominations of \$1000.00 each and payable March 15, 1933; March 15, 1934; and March 15, 1935, and bearing interest at the rate of 6% from March 15, 1932; the interest on the full amount due at the time of payment on each March 15th to be paid. The balance of \$200.00 on this proposal to be paid by the Supervisor of the Town of Palmyra, NY, on the acceptance of the grader.

It is also agreed that the Palmyra Town Superintendent shall take the machine from storage at Canandaigua, NY.

We hereby guarantee that the grader covered by this proposal shall be free from all defects in material or workmanship and hereby agree to replace any parts showing any defects at any time. This does not cover the motor, which is understood to be guaranteed by the motor manufacturer's standard guarantee.

We further agree that the complete machine shall give satisfactory service, and we agree to service the same for a period of ninety days.
