Meeting called to order by the Chairman Mr. Edgerton and Board declared in order for business

Motion made by Mr M. C. Finley that the Board adopt the following resolution which was carried unanimously

Palmyra N.Y. June 28th 1893

Myers American Ballot Machine Co.

Rochester N.Y.

Gentlemen you are hereby advised that the Town Board of the Town of Palmyra County of Wayne N.Y. did at a meeting of said Board held on the 28th day of June 1893 adopt the following resolution to wit: Resolved: that it is hereby determined and ordered that hereafter in all Town Elections held in the Town of Palmyra the Myers Ballot Cabinet shall be used in accordance with Chapter 82 Section 2 of the laws of 1893 until otherwise ordered by the Town Board and the Town Clerk is hereby directed to sign and send the order for 2 of said Myers Ballot Cabinets.

Therefore please manufacture for us 2 Myers American Ballot Cabinets or voting machines guarranteed to register the vote reliably when operated according to law. The same to be accompanied by complete instructions for use in the proper conduct of elections. Please mark and ship said voting machines to the Supervisor of said Town to Wm. W. Edgerton Palmyra R. R. Station County of Wayne N. Y. You are to deliver the same free of cartage at the Railroad Station in Rochester N.Y. so as to reach the above named destination in ample time for our next annual town election provided your facilities will permit. In accepting this order and supplying the Ballot Machines called for in this order you hereby grant to this town the especial right to use said machines in all legal elections now authorized or that may hereafter be authorized by law to be held by said town within the town above named and in no other place or places and for no other purposes. It is understood that all defective parts if any shall be corrected by you free of charge. It is hereby agreed as being one of the conditions of this order that the Town Board shall cause to be placed in said Ballot Machine a Ballot reading "For the adoption of the Ballot Machine" also one (adjacent and below) reading-"Against the adoption of the Ballot Machine" which question is to be voted upon at the annual Town Election of 1894, and it is further agreed that in case of majority of the voters voting at said election shall vote "Against the adoption of the Ballot Machine" then the Town Board may within 30 days after said election return said machine to the Myers Am. Ballot Machine Co. at Rochester in lieu of the consideration price otherwise the acceptance of said machine shall be conclusive. Subject to the foregoing conditions we agree within 10 days after the first annual election occurring next following the arrival of said voting machines at the destination above named to pay to you by remitting to you or your order your uniform price to wit:

Four Hundred and Eighty Dollars for each of said machines.

Our next annual Town Election occurs on the First Tuesday of March 1894, our Polls are held at Palmyra and are open form 8 o'clock A.M. until sunset.

The Board being unable to complete their labors to day adjourned to Friday Novr. 10th 1893 at same place at 10 o'clock A.M.

Novr. 10th 1893 – Board met as per adjournment and completed audit as above It was moved and carried that hereafter the three Village papers shall print the notice of the annual meeting to audit Town Bills to have two insertions the cost not to exceed one dollar.

Motion made and carried that hereafter this Board allow Fifty cents only as Constables fee for arresting a tramp as per fee given on page 13 Moons digest of fees published in 1890.

It was also moved and carried that hereafter the Constables are to be allowed only one day custody for a prisoner when the Board bill only shows that the prisoner had from one to three meals while confined.
