RESOLUTION:

Motion by David Nussbaumer to approve the following resolution:

A RESOLUTION RELATING TO THE INITIAL REVIEW, UNDER THE STATE ENVIRONMENTAL QUALITY REVIEW LAW, OF THE PROPOSED CREATION OF THE GARNSEY-SHILLING AREA WATER DISTRICT IN THE TOWN OF PALMYRA, WAYNE COUNTY, NEW YORK

The Town Board of the Town of Palmyra, duly convened in regular session, does hereby resolve as follows:

Section 1. Pursuant to, and in accordance with, the provisions of section 617.6 (Initial Review of Actions and Establishing Lead Agency) of the New York State Environmental Quality Review Regulations (6 NYCRR part 617) the Town Board of the Town of Palmyra hereby makes the following determinations and classifications with respect to the creation of the proposed Garnsey-Shilling Area Water District in the Town of Palmyra.

GARNSEY-SHILLING AREA DISTRICT – SET PUBLIC INFORMATION MEETING

1. The Town Board of the Town of Palmyra hereby determines that the action is subject to SEQR.

- 2. The Town Board hereby determines that the action does not involve a Federal agency, except the U.S. Department of Agriculture and the Army Corps of Engineers, but does involve the Department of Health and the NYS Department of Environmental Conservation.
- 3. The Town Board hereby makes a preliminary classification of the action as a Type I action.
- 4. The Town Board hereby determines that it is, and will be, the lead agency with respect to the creation of the above-described water district.
- Section 2. A public hearing with reference to the above-described proposed creation of a water district shall be held on December 26, 2002, at 7:30 p.m. at the Palmyra Town Hall, 1180 Canandaigua Road, Palmyra, NY. The Town Clerk of the Town of Palmyra is hereby authorized to publish a notice of said public hearing in the *Palmyra Courier-Journal* and to give notice thereof to other municipalities, boards and agencies entitled to notice thereof.
- Section 3. A copy of the proposed water district and a copy of this Resolution shall be sent by the Town Clerk of the Town of Palmyra to the Palmyra Town Planning Board, Wayne County Department of Planning, N.Y. State Commissioner of Agriculture and Markets, N.Y. State Commissioner of Environmental Conservation, and N.Y. State Office of Parks, Recreation and Historic Preservation.

Section 4. This Resolution shall take effect immediately.

GARNSEY-SHILLING AREA DISTRICT – SET PUBLIC HEARING TO ESTABLISH DISTRICT 3. Garnsey-Shilling Area District – Resolution – Set Public Hearing Date and order establishment of district

Motion by James Welch as follows:

RESOLUTION TOWN BOARD ESTABLISHING GARNSEY-SHILLING AREA WATER DISTRICT OF THE CENTRAL WATER DISTRICT

WHEREAS, the Town Board of the Town of Palmyra has caused a map, plan and report to be prepared by the Town Consulting Engineer, MRB Group, P.C. regarding the creation of the Garnsey-Shilling Area District to the Central Water

District providing water service to areas of the Town of Palmyra outside of the Village of Palmyra and outside of any existing water district; and

WHEREAS, there is a need for potable water along Shilling Road, Goldsmith Road and Lusk Road, north of the canal and along Garnsey Road south of the canal; and

WHEREAS, the boundaries of said proposed Garnsey-Shilling Area District are set forth on Schedule "A" attached hereto and made a part hereof; and

WHEREAS, the improvements proposed to be made are as follows:

- 1. Construction of 17,450? lineal feet of 8" watermain along Shilling Road, Goldsmith Road, Lusk Road and Harris Road north of the canal.
- 2. Construction of 7200? feet of 8" watermain along Garnsey Road.
- 3. Installation of 40? hydrants.
- Miscellaneous fittings and equipment to complete the installation; and

WHEREAS, the maximum amount to be expended for the improvements is \$739,500; and

WHEREAS, the Town has been awarded a priority for a grant of \$360,000; and

WHEREAS, the estimated cost of the project to be furnished by loan is \$379,500.

NOW, THEREFORE, BE IT RESOLVED, that said Town Board shall meet at the Town Hall, 1180 Canandaigua Road, Palmyra, NY on the 26th day of December, 2002, at 7:30 P.M. to consider said proposal and to hear all persons interested in the subject considering the same; and

BE IT FURTHER RESOLVED, that the Town Clerk of the town of Palmyra is hereby authorized and directed to publish a notice of said hearing in the *Palmyra Courier-Journal* and to post a copy of this notice of the hearing on the signboard at the Town of Palmyra in the time and manner as required by law.
