He feels there is great potential for earning income for the Zoning Department.

Michael Lambrix moved to set Thursday, February 25, 1999 at 7:30 PM as the time for a public hearing to consider the application for special authorization for Mike Porretta to erect a second building on his property located at Hammond Road. Palmyra and for such public hearing to take place at the Palmyra Fire Hall, East Main Street, Palmyra.

AGENDA ITEMS

1. Proposed East Sewer District

Supervisor Lyon discussed, with the Board Members, the possibility of running a sewer line in the East District from the village line to the Rt. 31 intersection. The board thought this might be a good idea and suggested we get some input from the residents in that area. Supervisor Lyon told

the board that he would write a letter to the property owners in that area and he will get back to them with the results of his inquiry.

Lynne Green moved to approve the Town of Palmyra submit an application under the Small Cities Community Development Block Grant (CDBG) Program to extend sewers to an industrial park site on Division

Street in the Town of Palmyra.

2. Approval of Small Cities Grant Application

Division Street Sewer District – Declare Negative Declaration
 The following resolution was moved by Michael Lambrix:

WHEREAS, the Town of Palmyra has previously declared its intent to serve as Lead Agency for the North Sewer District Project; and

WHEREAS, this project has been determined to be an Unlisted Action with a desired coordinated review by all involved agencies in accordance with the State Environmental Quality Review Act (SEQR); and

WHEREAS, the Town of Palmyra has duly notified all involved agencies of its intent to serve as Lead Agency for this project, and allowed for said agencies to respond to the Town's request to be Lead Agency, as required; and

WHEREAS, the Town of Palmyra has duly reviewed the long EAF, and other related documents with respect to the above captioned improvement project and has duly considered the impacts which may be expected to result from the proposed action in accordance with the criteria set forth in Article 8, 6NYCRR, Section 617.7 of the State Environmental Quality Review Act (SEQR); now

THEREFORE, be it resolved that the Town of Palmyra hereby declares itself Lead Agency for the North Sewer District Project, and

BE IT FURTHER RESOLVED; that after review of the Environmental Assessment Form, the Palmyra Town Board, acting as Lead Agency, has determined that the proposed action will not have significant environmental impact, and that a Negative Declaration of Environmental Significance shall be prepared; and

BE IT FURTHER RESOLVED; that based on this environmental review and determination of environmental significance, the Palmyra Town Board, acting as Lead Agency for the above action, hereby authorizes the supervisor to prepare a Negative Declaration of Environmental S8ignificancefor the proposed action known as the North Sewer District Project; and

BE IT FURTHER RESOLVED; THAT THE Palmyra Town Board hereby authorizes the Town Supervisor to file said Negative Declaration of Environmental Significance with the appropriate agencies, and to conclude the SEQRA process for the proposed action.

3. Resolution to establish the North Sewer District subject to permissive referendum

The following resolution was moved by David Nussbaumer:

RESOLUTION OF THE TOWN BOARD ESTABLISING THE NORTH SEWER DISTRICT

A meeting of the Town Board of the Town of Palmyra was held at the Palmyra Fire Hall, in the Town of Palmyra on January 28, 1999 at 8:00 PM on the matter of the Establishment of the North Sewer District in the Town of Palmyra, pursuant to Article 12-A of the Town Law.

A map, plan and report relating to the establishment of a proposed Extension to the North Sewer District, prepared by MRB Group, P. C., competent engineers, licensed by the State of New York, in the manner and detail required by the Town Board has been filed with the Town Clerk of the Town of Palmyra, in accordance with the requirements of Article 12-A of the Town Law.

On December 28, 1998 an Order was adopted by the Town Board reciting the filing of the map, plan and report, the boundaries of the proposed North Sewer District, the improvements proposed, the estimated expense of these improvements, the proposed method of financing, the fact that the map, plan and report are on file in the Town Clerk's Office for public inspection and all other matters required by law to be stated.

The Order set January 14, 1999 at 8:00 PM at the Palmyra Fire Hall, East Main Street, Palmyra, New York, to consider the map, plan and report and to hear all persons interested in this matter and to take action as required by law.

The Order was published and posted as required by law.

A hearing on the matter was held by the Town Board on January 14, 1999, at 8:00 PM and the matter was adjourned to January 28, 1999.

Upon evidence given at the hearing and upon a motion made and seconded, the following resolution was unanimously adopted:

It is hereby determined that:

- A. The notice of hearing was published and posted as required by law, and is otherwise sufficient.
- B. All the property and property owners within the proposed sewer district are benefited thereby.
- C. All the property and property owners benefited are included within the limits of the proposed sewer district.
- D. The establishment of this sewer district is in the public interest.
- E. That the proposed sewer district is outside of the Village of Palmyra and any existing district.

IT IS FURTHER DETERMINED AND RESOLVED, that the sewer district, as set forth in the map, plan and reports be approved, that the requested improvement be constructed, and that the necessary easements and lands be acquired, upon the required funds being make available and provided for.

IT IS FURTHER RESOLVED, that this district shall be known as the North Sewer District in the Town of Palmyra and shall be bounded and described as follows:

Commencing at a point in the north line of the Village of Palmyra approximately 500 feet west of the centerline of Division Street; thence northerly to the south line of the property known as Palmyra Air Park; thence westerly and northerly along the south and west boundaries of the Palmyra Air Park and thence continuing northerly along the east boundary of the Williams and Haak Subdivision to the north line of premises of Division Street Partners, LLC; thence easterly along the north line of premises of Division Street Partners, LLC to the west boundary of Conrail; thence southerly and easterly along the west and south boundaries of Conrail to the west boundary of New York State Route 21; thence southerly to the west boundary of New York State Route 21 to the north line of the Village of Palmyra; thence westerly along the north line of the Village Of Palmyra to the point and place of beginning.

IT IS FURTHER RESOLVED, that this resolution is subject to permissive referendum as provided in Town Law Section 209-e, in the manner provided in Article 7 of the Town Law, and

IT IS FURTHER RESOLVED, that the Town Clerk shall cause to be published and posted in the Town, a notice that the above resolution was adopted pursuant to a permissive referendum as provided in Article 12-A of the Town Law in the manner provided in Article 7 of the Town Law, and

IT IS FURTHER RESOLVED, that in the event a petition is not received as required by law requiring a referendum, the Town Clerk shall prepare a certificate state "that petition was not received: suitable for filing with the County and Town, and

IT IS FURTHER RESOLVED, that the Clerk shall file a certified copy of the Order creating the sewer district within 10 days of creation of the North Sewer District with the Wayne County Clerk.
