## Town of Palmyra – 1931 Minutes

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Monday, January 19, 1931. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, William E. Spier, and Kingsley F. Young, Justices; and Harry E. Williamson, Clerk. The meeting was called to order by Supervisor Averill, and minutes of the last meeting were read and approved.

Town Superintendent DeBrine was present at the meeting and stated that the new Ford dump truck had been delivered and that the new International truck had proved very satisfactory in the work of shoveling snow. He also stated that the GMC truck had been re-built and was now in first-class condition.

Supervisor Averill showed the amount that had been spent in the various funds since the last meeting. He also showed the Board a copy of the Supervisor's report to the Comptroller for their inspection.

The Wayne County Trust Company, the depository of the town funds asked the Board to allow the bank to reduce the rate of interest on town funds from 3% to 2%, the rate that has been fixed by the State of New York for all state funds. The matter was discussed at length; and on motion of Mr. Young, seconded by Mr. Spier, the resolution was unanimously adopted.

Whereas the State of New York has fixed the rate of interest on all state funds on deposit in the various banks in the state of New York at 2%. The Palmyra Town Board, believing that the state rate is fair and equitable, be it hereby

Resolved that the Palmyra Town Board does hereby agree to accept the rate of 2% on all future town deposits until this resolution is rescinded, and be it further

Resolved that the bank(s) holding such deposits furnish a suitable bond covering the full amount of the deposit.

Mr. Herrick explained the law relative to the lighting of bridges by the Towns.

Young, Justices; and Harry E. Williamson, Town Clerk. The meeting was called to order by the Supervisor, and the minutes of the last meeting were read and approved.

The matter of the Town adopting the provisions of Section 66 of the Transportation Corporation Law of New York State was discussed at length. The following

resolution was adopted, and the Clerk was instructed to send a copy of said resolution to the Public Service Commission:

"Resolved that the provisions of Section 66 of the Transportation of New York State forbidding a stage, omnibus line, stage route, motor vehicle line, route, or any vehicle in connection therewith from being operated wholly or partly upon or along any street, highway, or public place and forbidding the issuance of a certificate of public convenience and necessity therefore until the owner(s) thereof shall have procured the consent of the local authorities shall be adopted by the Palmyra Town Board thereof. That such provision shall apply to the Town of Palmyra; the that no stage, omnibus, motor vehicle, or route shall be operated wholly or partly upon or along any street or highway in the said Town of Palmyra, nor shall a certificate of public convenience or necessity be issued therefore, until the owner(s) thereof shall have procured the consent of the local authorities of the said Town of Palmyra in the same manner and subject to the same terms and conditions as is provided in Section 66 of the Transportation Corporation Law."

A petition was present to the Board from the Syracuse and Rochester Bus Lines, Inc. making application for consent to operate a motor bus line over certain streets and roads in the Town of Palmyra, Wayne County under Sections 66 and 67 of the Transportation Corporation Laws.

The application was considered and discussed. The following resolution was adopted: Resolved that the Palmyra New York Town Board entertain the application of the Syracuse and Rochester Bus Lines, Inc. for consent to operate a motor bus line upon and over the highways of the Town of Palmyra and that a public hearing be held thereon in the Justice Room in the Palmyra, New York Village Hall on the 1st day of May, 1931, at 2 o'clock p.m., and that the said Town Board act upon such application at such time and place. Further that notice of such public meeting be published in the Palmyra Courier Journal, a weekly newspaper published in the Town and Village of Palmyra, New York, in its next two succeeding publication and such other notice as required by law be duly given.

Petition for consent of local authorities to operate a motor vehicle line over state highway easterly and westerly through the Town of Palmyra by the Eastern Greyhound Lines, Inc. of New York left at the Town Clerk's Office by Mr. C. B. Brasser of Williamson, New York, was brought before the Board. After discussion and consideration and in view of the fact that the application of the Syracuse and Rochester Bus Lines, Inc. for consent to operate over substantially the same route had been received by the Board some time since, and also the fact that prior to the time the proposed application of Easter Greyhound Lines, Inc. of New York had been brought to the knowledge of any member of the Board, the application from the Syracuse and Rochester Bus Lines, Inc. had been received, acted upon, and a notice of a public hearing called for May 1<sup>st</sup>, 1931, authorized which due notice had been heretofore given, it was the unanimous thought of the member of the Board that before any action was taken upon the application of the Eastern Greyhound Lines, Inc. that the hearing heretofore called should be had and that as proper courtesy to this last applicant, it should be advised of the date of the hearing so that it might have the opportunity to appear at such hearing if it so desired.

No address of the last applicant or of its general counsel being given on the papers, and the papers having been left that the Town Clerk's Office by Mr. C. B. Brasser, Attorney, at Williamson, New York, the following resolution was duly offered, seconded and unanimously adopted:

Resolved that the Town Clerk advise Mr. C. B. Brasser of Williamson, New York, as local counsel for the Eastern Greyhound Lines, Inc. of New York that the papers relating to the application of the Eastern Greyhound Lines, Inc. were this day brought to the attention of the Town Board considered and discussed. After due deliberation, the Town Clerk was directed to advise the Eastern Greyhound Lines, Inc. of New York through Mr. C. B. Brasser of Williamson, New York, its local counsel that a public hearing had been heretofore set upon a prior application for permission to operate a motor vehicle line through the Town of Palmyra. Said hearing had been fixed for May 1st, 1931, at 2 o'clock p.m. at the Justice Room in the Palmyra, New York Village Hall, and that any representative of the Greyhound Line, who desired to appear at such hearing is courteously invited to be present.

Now therefore be it resolved that said petition be received and placed on file, and that this Town Board convene in Special Session on the 6th day of June, 1931, at 2 p.m. at the Village Justice Room in the Town and village of Palmyra for the purpose of further considering said petition an application and acting thereupon, and that at said time and place a public hearing be held at the village Hall on the 26th day of June, 1931, at 2 p.m. upon said petition as required by law, and that public notice of such hearing and of time and place thereof be given by publishing the same in the Palmyra Courier Journal, a newspaper published at Palmyra, NY, in at least two issues of said paper, which notice shall be deemed to be sufficient notice of said hearing.

Meeting of the Palmyra Town Board was held at the Town Clerk's Office on Thursday, July 2, 1931. Present: Harry L. Averill, Supervisor; Louis C. Ziegler, William H. Chapman, and Kingsley F. Young, Justices; and Harry E. Williamson, Town Clerk. The meeting was called to order by the Supervisor Averill, and the minutes of the last meeting were read and approved

George S. Tinklepaugh as attorney for the Town then presented a proposed form of franchise and consent to the Eastern Greyhound Lines, Inc. of New York consent or permission to operate its motor vehicle line over and along certain highways in the town. By direction of the Supervisor the said proposed franchise was read; and consideration and in judgment of the Board, it being in compliance with the general discussion held at

the last meeting of the Board, the following resolution was offered by Mr. Ziegler, seconded by Mr. Chapman; and was upon roll call duly and unanimously adopted:

Resolved that the preamble and resolution granting to the Easter Greyhound Lines, Inc. of New York permission and consent to operate its motor vehicle line over certain highways in the town of Palmyra, New York, as more particularly set forth in the said proposed consent be and same is hereby adopted.

And be it further resolved that a copy of said preamble and consent be set forth in full upon the records. The original as read be placed upon the permanent files of the Town. The certified copy thereof served upon the grantee by registered mail.

The following is a true copy of the preamble and consent above referred to: Whereas Eastern Greyhound Lines, Inc. of New York, a transportation corporation organized under and pursuant to the laws of the State of New York, and having its principal office and place of business at Watertown, New York, did heretofore and on or about the 15th day of April, 1931, file with the Clerk of the Town of Palmyra, New York, a petition in writing, duly verified, praying for permission and consent to operate a motor vehicle line or route upon, along, and over certain streets or roads in the said Town of Palmyra, New York, in connection with a route or line between the City of Syracuse, New York, and the City of Rochester, New York, along Route 5-31 and 31A, so-called as hereinafter set forth;

And whereas said petition was duly received and placed on file and a resolution duly adopted by this Board on June 6, 1931, calling and ordering a public hearing to be held upon said application on the 26th day of June, 1931, as required by law.

And whereas said public hearing was duly published and advertised and proof thereof filed with the Clerk of the Town of Palmyra. Said public hearing was duly held at the time and place specified in said resolution and all person interested therein having been given an opportunity to be heard;

And whereas it is the opinion of this Board that public necessity and convenience require the establishment of such a motor vehicle line or route as herein and in said petition referred to,

Now therefore be it ordained that subject to the following and hereinafter set forth covenants, agreements, terms, condition, and reservations the Eastern Greyhound Lines, Inc. of New York, hereinafter referred to as the "Grantee," be and it hereby is granted permission and consent of the local authorities of the Town of Palmyra, NY, to operate motor buses upon a motor vehicle line or route for the carrying of passengers and their baggage for hire during a period of five years next succeeding this date and no longer over the following streets and highways in the Town of Palmyra, New York; viz:

Commencing at the eastern boundary or margin line of said Town of Palmyra continuing over and along said Highway No. 31, so-called, through said Town to the eastern boundary of the Village of Palmyra in said Town of Palmyra and returning by same route.

The covenants, agreements, terms, condition, and reservations above referred to are as follows: 1. That the operation of said motor vehicle line or route and the motor buses thereupon shall at all times be subject to such rules, regulations, ordinances, and conditions as are now in force in the said Town of Palmyra, New York, or that said Town through its duly constituted officials, boards, or departments may hereafter or from time to time legally prescribe.

- 2. That said Grantee shall at all times operate in strict conformity with all laws of the State of New York and with all orders, rules, or regulations of the Public Service Commission of the State of New York, or any other public authority having jurisdiction in the premises now in force or which may hereafter be promulgated.
- 3. That this consent shall not become operative unless, and until a Certificate of Convenience and Necessity for the operation of said line or route shall have been granted by the Public Service Commission of the State of New York to the Grantee. This consent shall also become and be void and of no effect thirty days after the entry of any order of the Public Service Commission of the State of New York denying to the Grantee a Certificate of convenience and Necessity, or if such order shall be appealed from thirty days after the entry of a final order upon and appeal from such decision confirming same.
- 4. That the Grantee shall commence operation as a public carrier of passengers with omnibuses within thirty (30) days after the issuance of the Certificate of Public Necessity and Convenience. Failure to so operate shall render this consent or permit null and void.
- 5. That should vehicular traffic be diverted from any of the streets or highways forming a part of the route herein specified for any reason whatsoever or should any such street or highway be closed temporarily to vehicular traffic, which right to close such streets or highways temporarily to vehicular traffic is hereby expressly reserved to the grantor herein, the grantee herein during such time that such vehicular traffic may be diverted, or during the time of such temporary closing of any such street or highway, may use such other streets or highways as may be necessary for the operation of said line or route, but only as directed by the proper authorities of said town of Palmyra having charge of streets or highway and the traffic thereupon.
- 6. The Grantee shall be entitled to charge passengers either with or without hand baggage or hand parcels for a single ride in one direction with such baggage or parcels any reasonable rates of fare, but in no event shall a greater fare be collected than the highest fare heretofore charged by the Rochester and Syracuse Railroad Company, Inc. for similar transportation between similar points along the line so served by the said Rochester and Syracuse Railroad Company, Inc.
- 7. That all omnibuses or vehicles for the transportation of passengers which are commonly known as "local" shall stop at any point along its route in said town upon signal to receive and/or discharge passengers.

- 8. That the said Grantee shall promptly pay to the Town of Palmyra, New York, for any damages to its highways, guard rails, or bridges occasioned by the said Grantee, its agents, servants, and employees--ordinary wear and tear excepted.
- 9. That in consideration of the granting of this consent, said Grantee hereby waives and releases the Town of Palmyra, its officers, officials, agents, and employees of and from each and every claim, which it might-except for this waiver and release be permitted by law to make against it, him, and/or them by reason of any act or omission of any officer, official, agent, or employee or said town, particularly as to removal of snow and ice, and generally as to omission to perform any duty which it might be claimed was by law imposed upon said town, its officers, officials, agents, and employees as to care and maintenance of said highway and land adjacent thereto under it jurisdiction.
- 10. That the Grantee in consideration of the granting of this consent and by the acceptance of and/or operation under this consent or franchise assumes, and it hereby does assume and agree with the town of Palmyra that it will protect and indemnify the said Town of Palmyra, its officers, officials, agents, and employees of and from all claims and demands for damages suffered or claimed to have been suffered by any person and/or person, co-partnership, corporation or otherwise by reason of any act, matter, or thing claimed to have been caused by or claimed to have resulted from the operation or maintenance of omnibuses authorized to be operated within the town of Palmyra by virtue of this consent and to protect and defend in the name and on behalf of the said Town of Palmyra, its officers, officials, agents, and employees, but at its own expense any suit or suits, action or actions at law brought in which the Town of Palmyra or any of such parties shall be named as defendant claiming damages by reason of any injury either to person or property or otherwise claimed to have been suffered by reason of or in connection with the operation of said bus route over and through streets and highways of the Town of Palmyra where claim is made that said town or any of its officers, officials, agents, or employees have in any either by affirmative or negligent act or acts or omission of duty upon its, his, or their part in any way contributed or been a party to the cause of such damages and will assume make its own and pay each and every judgment or claim which shall be sustained against the said town or any such parties upon any of the grounds hereinbefore stated with all cost or interest which may accrue and otherwise to the end that no expense shall at any time hereafter be caused to the town or any such parties or the said town or any such parties obliged to defend any litigation or any claims, demands, judgments, or expenses in connection therewith which shall have been caused or claimed to have been caused by any affirmative act or any alleged or actual negligence, omission of duty, or otherwise on the part of either the Grantee or the town or any of its officers, officials, agents, or employees and occasioned through the medium of the operation of buses pursuant to this consent.
- 11. That the Grantee for said consideration does also covenant and agree to and with the said town of Palmyra and by the acceptance of and/or operation under this franchise does covenant and agree that it willmake no claim for damages of any kind by reason of any act or omission on the part of the town of Palmyra, its officers, officials, agents, and/or employees for, or by reason of which it otherwise might make claim for damages claimed

to have been suffered by it while operating under this franchise. It further covenants and agrees generally to protect and indemnify the Town of Palmyra, its officers, officials, agents, and/or employees of and from all costs, damages, expenses, and liability which may hereafter be incurred by the said town, its officers, officials, agents, and/or employees in favor of any person or party claimed to have been sustained by, or in connection with or resulting from the operation of or riding as a passenger in the omnibuses or vehicles of the Grantee over any of the streets and/or highways and/or public places in the Town of Palmyra.

- 12. This permission and consent to operate a motor vehicle line over the hereinbefore described route is granted and is to be used by the Grantee jointly with other lawful users of the said highways and streets and shall not be construed as in any way limiting or restricting the right of said Town of Palmyra to grant other or similar rights to others person, firms, or corporations for the operation of motor vehicle over and upon the highways above described.
- 13. That his consent may be revoked for cause after a hearing and after ten (10) days notice in writing thereof to be given to said Eastern Greyhound Lines, Inc. of New York.
- 14. All terms, conditions, reservations, and restrictions hereinbefore contained are to be construed as extending and not as limiting the right and powers of the said Town of Palmyra and shall not be construed as in any way limiting or restricting any rights or privileges which now are or hereafter may be given by any law or statute to towns upon the subject of regulating or restricting the rights and powers of transportation corporation.

Be it ordained that the Clerk of the town of Palmyra, New York, shall forthwith serve a certified copy of this ordinance upon the said Easter Greyhounds Lines, Inc. of New York by registered mail. The said Easter Greyhound Lines, Inc. of New York shall file within ten days thereafter with the said Clerk a written acceptance of said consent duly acknowledged as are deeds entitled to be recorded. Such acceptance shall be construed to be an acceptance of this ordinance, subject to all of the covenants, agreements, terms, conditions, reservations, limitations, and obligations herein provided to be kept, observed, and performed by said Grantee.

Failure to file such written acceptance within the time above set forth shall operate as a refusal to accept the rights and privileges hereinbefore granted, and all rights which would otherwise pass unto the Eastern Greyhound Lines, Inc. of New York by reason of the adoption of the foregoing resolution shall automatically cease and terminate upon its failure to so accept the rights and privileges as above provided.

This resolution shall take effect immediately.
