Dear Sir: Recently you requested my opinion as to the power of the Town Board to acquire real property with a building thereon in the name of the Town for the purpose of using the property to house the various town offices.

Section 64 of the Town Law defines the general powers of a Town Board, and subdivision 2 of this section so far pertinent to the question here involved reads as follows: "Acquisition and conveyance of real property. May acquire by lease, purchase, or by condemnation in the manner provided by law, any lands or rights therein, either within or outside the town boundaries, required for any public purpose."

This provision of Section 64 seems to be ample authority for the Town Board to purchase real property for the purpose you have in mind.

However, under the budget setup, the annual budget for this year has been approved, and additional appropriations can only be made to meet emergencies. The purpose you have in mind does not come within the emergencies as defined by statute. Section 118 prohibits certain contracts and expenditures and specifically seems to bar such a purchase as you have in mind.

If the Town Board deems the purchase of read property for office purposes desirable and for the best interest of the Town, I think the Board could take an option and provide the funds to cover the purchase in the next annual budget.

For many years the Village of Palmyra has furnished fire protection to the areas surrounding the Village of Palmyra, and at no compensation other than some years ago when a flat charge was sent to the person(s) owning the property where a fire occurred. Sometimes this was paid, and sometimes not.

The Village is now in a position where it will be unable to continue to furnish fire protection to the area surrounding the Village, unless the Village purchases another modern fire truck fully equipped for such use, which will represent a substantial outlay of money. The Village wishes to cooperate with the Town in every way possible and furnish fire protection to the surrounding area; but after considerable deliberation, the Village Board has deemed it best to request the Town to set up a fire protection district covering that portion of the Town which is not embraced in the East Palmyra Fire Protection District. The Village Board feels that if some reasonable arrangement can be made between the Town and Village for the Village to furnish fire protection, this will enable the Village in turn to purchase and finance an additional truck equipped with modern fire-fighting equipment for both rural and village use.

The Village Board of Trustees will appreciate it if you will consider this letter as a formal request on its part that the Town take such steps as are required to set up a fire protection district to embrace the area outside the Village of Palmyra, which is not included in the East Palmyra Fire Protection District.
