CEO Software Proposal

Bob Grier presented the board with information about a special software which is specially designed for Code Enforcement Officers and building inspectors. It can be used with hand-held devices in the field, and can interface with the main PC in the office. The price is set at \$4,000, which includes training and installation. Annual software, service and support is \$950. Grier said the annual fee can be paid through his equipment and software budgets. The cost is also 60% reimbursable from NY State, making the net cost \$1,400.

The Town Deard of the Town of Delmure, Woung County, New York, has coursed

hear all persons interested in the creation of the District, and for any other action on the part of the Town Board concerning the proposed district as might be required by law.

The Order was published and posted in the manner and within the time prescribed by Town Law Section 209-d, and proof of the publication and posting has been presented to the Town Board.

The Public Hearing was held at the time and place set forth in the Order and all persons desiring to be heard were heard.

Following the public hearing and based upon the evidence presented at the hearing, the Town Board, on December 26, 2002, adopted a resolution subject to permissive referendum determining in the affirmative all of the questions set forth in Town Law Sec. 209-e (1) and approving the establishment of the District.

Notice of the adoption of the Resolution was published and posted in the manner required by law and proof of the publication and posting has been presented to the Town Board.

The permission of the State Comptroller for the establishment of the District was not necessary as the cost per single Family Unit is less than the Five Hundred Ninety Seven Dollars (\$597.00) per typical residence, the amount established by the State Comptroller requiring submission for the approval of the State Comptroller's Office.

It is hereby ORDERED as follows:

1. Garnsey-Shilling Area Central Water District of the Town of Palmyra, Wayne County, New York, is hereby established substantially in accordance with the above map, plan and resort and the District shall be bounded and described as follows:

The construction of the proposed improvements for the district, consisting of a water system, including water mains, distribution pipes, hydrants, reservoirs, and including a proposed plan of purchase of water from the Wayne County Water and Sewer Authority, and including the purchase of the assets, if any, which presently operates a water system within a portion of the proposed district, and also including land or rights in land, original furnishing, equipment, machinery or apparatus incidental thereto,

substantially as set forth on the man inlan and report to it hereby sutherized as a

ORDERED that the proposed improvements, including costs of right-of-way, construction costs, legal fees and other expenses shall be financed as follows:

That a maximum amount be expended not to exceed \$739,500 that the improvements be financed by the receipt of an RUS Grant of \$360,000, that the balance be financed by serial bonds providing for amortization of the balance of the costs of the improvements for a period of not more than 38 years, and it is further,

ORDERED that the Town Clerk of the Town of Palmyra is hereby authorized and directed to cause a certified copy of this Order to be duly recorded in the Office of the Clerk of the County of Wayne, in which the Town of Palmyra is located, within ten (10) days after the adoption of this Order; and it is further

ORDERED, that the Town Clerk is hereby authorized and directed to file a certified copy of this Order in the Office of the State Department of Audit and Control, Albany, New York within ten (10) days after the adoption of this Order.

4. This Order shall take effect immediately.

d. "A RESOLUTION AUTHORIZING THE CONSTRUCTION OF A WATER DISTRIBUTION SYSTEM TO SERVE GARNSEY-SHILLING AREA WATER DISTRICT IN THE TOWN OF PALMYRA, WAYNE COUNTY, NEW YORK, AND AUTHORIZING THE ISSUANCE OF \$379,000 SERIAL BONDS OF SAID TOWN TO PAY THE COST THEREOF"

BOND RESOLUTION FOR GSAWD

Bond Resolution dated January 30, 2003 was read by the Town

DISTRICT IN THE TOWN OF PALMYRA, WAYNE COUNTY, NEW YORK, AND AUTHORIZING THE ISSUANCE OF \$379,500 SERIAL BONDS OF SAID TOWN TO PAY THE COST THEREOF.

WHEREAS, by proceedings heretofore duly had and taken pursuant to Article 12A of the Town Law, the Town Board of the Town of Palmyra, Wayne County, New York, has duly established the Garnsey-Shilling Area Water District in said Town; and

WHEREAS, it is now desired to authorize the construction of the improvements proposed for said Water District and provide for the financing thereof in accordance with said proceedings;

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Palmyra, Wayne County, New York, as follows:

Section 1. The construction of the improvements proposed for the Garnsey-Shilling Area Water District in the Town of Palmyra, Wayne County, New York, consisting of a water distribution system, including water main, storage facilities, distributing pipes and hydrants, with appurtenant facilities, substantially in accordance with the map and plan accompanying the petition for said District, is hereby authorized at a maximum estimated cost of \$739,500 (Exhibit 1)

Section 2. The plan for the financing of such maximum estimated cost is to issue debt obligations up to \$739,500, which sum is to be reduced dollar for dollar for the amount of the U. S. Department of Agriculture grant funds received, presently estimated at to be \$360,000.00 and the issuance of \$379,500 of serial bonds (and bond anticipated notes) of said Town hereby authorized to be issued therefor pursuant to the Local Finance Law.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is 40 years, pursuant to subdivision 2, paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed 5 years.

Section 4. The faith and credit of said Town of Palmyra, Wayne County, New York, are hereby irrevocably pledged to the payment of the principal of and interest on such bonds as the same become due and payable. There shall annually be assessed upon all the taxable real property in said Garnsey-Shilling Area Water District at the same time and in the same manner as other Town charges an amount sufficient to pay said principal and interest as the same become due and payable, but if not paid from such source, all the taxable real property within said Town shall be subject to the levy of ad

<u>Section 6</u>. The validity of such bonds may be contested only if:

- 1. Such bonds are authorized for an object for purpose for which said Town is not authorized to expended money, or
- 2. The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
 - 3. Such bonds are authorized in violation of the provisions of the Constitution.

Section 7. This resolution, which takes effect immediately, shall be published in full in the <u>Courier Journal</u>, the official newspaper, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

e. Contract with Tim McGill, Esq., for Bond Counsel

1. Each issuance of temporary debt (notes): base charge of \$500, plus \$.75 per thousand dollars of notes issued, payable upon issuance of such obligations;

MTN: CONTRACT WITH TIMOTHY McGILL, ESQ. AS BOND COUNSEL FOR GSAWD Internal Revenue Service, and the like, or in the event debt is not issues: legal fee at regular hourly rates.

The fees for the services described under paragraphs 1 and 2 above include the preparation of all typical authorizing resolutions and documents and procedures. I would not undertake any such extraordinary services without your prior request.

* For engagements extending beyond one year from the date hereof (November 15, 2002), fees will be adjusted annually by the change in the Consumer Price Index, all Urban Consumers— Northeast Urban Rate.

In addition to the legal fee, I render a statement at each closing for out-of-pocket disbursements, the largest of which are typically photocopying, courier services, telephone, fax transmissions and travel expenses, if required.

If acceptable, kindly execute the enclosed copy of this letter in the space provided and return it to me at your convenience. I appreciate this opportunity to be of service and look forward to working with the Town.
